- (4) Evidence of Degree in Health Sciences, MBBS, Public Health, Statistics, Epidemiology or equivalent;
- (5) Verifiable documentary evidence of at least 7 years' experience in monitoring and evaluation of Malaria, TB or HIV programs and experience in the management information systems in the public sector;
- (6) Evidence of training and experience in logical framework, project management and setting up of program evaluation systems in Health programs;
- (7) Evidence of demonstrated experience in designing and implementing M&E systems, performance frameworks, project management, and program/project evaluations within the health sector;
