- (h) Company's Audited Account for the last three (3) years (2015, 2016, and 2017) duly stamped.
- (i) Evidence of Financial Capability to execute the project including Reference letter from a reputable commercial bank including willingness to provide credit facility for the execution of the project when needed;
- (j) Company profile with the Curriculum Vitae of key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON etc.).
- (k) Verifiable documentary evidence of having successfully carried out at least three (3) similar jobs in the last five (5) years including Letters of Awards from recognized Government or other reputable Agencies, Valuation Certificate, Job Completion Certificates and Photograph of the projects.
- (I) List of Plants/Equipment with proof of ownership/Lease (where applicable);
- (m) All documents for submission must be transmitted with a Covering/ Forwarding letter under the Company/Firm's Letter Headed Paper bearing amongst others, the registration Number(RC) as issued by the Corporate Affairs Commission (CAC), Contact Address. Telephone Number (preferably GSM No), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm;
