PROCUREMENT, SUPPLY AND COMMISSIONING OF SIX (6 NOS.) TRIPLE AGENT
FIREFIGHTING TRUCKS FOR NPSC OPERATIONS**

1.0 INTRODUCTION

The Nigerian Pipelines and Storage Company (NPSC) Intends to carry out the procurement, supply and commissioning of six (6 nos.) triple agent firefighting trucks for NPSC operations.

In this regard, NPSC hereby requests suitably qualified, experienced and reputable prospective Contractors to submit their pre-qualification documentation, which shall be in English language.

2.0 BRIEF DESCRIPTION OF THE SCOPE OF WORK

The Procurement Contract scope of work shall cover but not limited to the factory inspection of existing facilities, engineering, detailed design, construction, procurements supply of 6 nos. triple agent firefighting trucks, testing, commissioning and training of 12 NPSC HSE Staff at the Manufacturer's facility/location.

The firefighting truck units are expected to be delivered at NPSC Mosimi Central Warehouse.

In line with the above, the following shall form but not limited to the scope of work to be executed:

- 2.1 Precision/Procurement of 6 nos. new triple agent firefighting trucks
- 2.2 Model: Mercedes Benz Actross 3331 Triple Agent
- 2.3 Engine: Diesel 4 strokes direct injection turbo-charged & interceded V6 230Kw (313HP) @1800rpm with max torque 2000NM
- 2.4 Drive: 6X4 rear wheels drive. G120-16 (Manual – 16 speed + 2 reverse) transmission.
- 2.5 Cabin: Single type – hydraulic tilt forward, two doors, three seats (driver + 2 firemen)
- 2.6 Suspension: Leaf springs-parabolic (fronts rear-cantilever)
- 2.7 Tyres: 12.00R20 (on & off road). Rims – drop center 8.50 X 20

- 2.8 Brakes: MB Telligent braking system
- 2.9 Battery: 2x12V165AmH
- 2.10 Water Tank: 0.000 litres (AISI316L stainless steel, 3mm thickness)
- 2.11 Foam tank: 1.000 litres (AISI316L Stainless steel, 3mm thickness suitable for synthetic and protein foam compound)
- 2.12 Fire Pump: centrifugal single stage water booster pump (rear) 5.000L/min @ 10bar (at 3m suction height) impeller made of bronze, shaft of stainless steel with mechanical seal. Driven by truck engine through suitable Power-Take-Off.
- 2.13 Powder: 1,000kg dry chemical powder
- 2.14 Throw: Water – 75m
Foam-65m
Powder-25 to 30m
- 2.15 All other works required to complete and achieve overall project objectives
- 2.16 Provision of as-built documentations, operations and maintenance manuals
- 2.17 Training of 12 nos. NPSC HSE personnel at the Manufacturer's facility/location

3.0 PRE-QUALIFICATION REQUIREMENTS

Those interested in the pre-qualification process are required to submit comprehensive technical and financial information as follows:

- 3.1 Full details of company profile with Certificate of Incorporation in Nigeria, certified true copies of memorandum and article of Association of the company and CAC form C02 and C07 (Particulars of Directors)
- 3.2 Company Tax Clearance Certificate for the last three (3) years (2012, 2013, 2014)
- 3.3 Evidence of VAT registration and Remittance
- 3.4 Evidence of compliance with part IV. 16(6d) of the Public Procurement Act 2007 as it relates to PENSION (Certificate or exemption from PENCOM) and section 1(2) Pension Reform Act 2004.

3.5 Evidence of compliance with the Industrial Training Fund (ITF) Amendment Act 2011 by inclusion of copy of Compliance Certificate from the Industrial Training Fund (where applicable)

3.6 Audited Accounts for the past three (3) years (2012, 2013, 2014).

3.7 Nigerian content plan that demonstrate full utilization of Nigerian Labour and services with detailed description of role, work scope and man-hours in order to achieve minimum target as set out in the requirements of the Nigeria Oil and Gas Industry Content Development (NOGICD) Bill, 2010. (where applicable)

3.8 Current in-place organizational structure with detailed experience and skill of key management personnel with names. Provide evidence (personnel list and position organizational chart) percentage of management that are Nigerian Nationals and the percentage of the total workforce that are Nigerians

3.9 Detail past/present commitment to staff training and development of Nigerian personnel.

3.10 Evidence of financial capability/Bank reference.

3.11 Evidence of relevant verifiable experience on similar works in Nigeria over the past five (5) years. Please attach reference letters.

3.12 List of verifiable similar works detailing companies that the works were rendered to include company full contact details (Not P.O. Box), functional phone numbers and e-mail address.

3.13 Confirm willingness to commence with the execution of this work on the basis of a Letter of Intent (LOI).

3.14 Company's CASHES and QA/QC policy & details of safety records for accidents, incidents, injuries and damages for the past three (3) years. E.g. Lost time incident, Down-Time. etc.

3.15 Copy of Company's registration certificate with Corporate Affairs Commission (CAC), and current Department of Petroleum Resources (DPR) permit.

3.16 Copy of Contractor's registration certificate with NNPC or any of its subsidiaries.

3.17 Any additional Information that will enhance the potentials of the company.

NOTE: Failure to meet any of 3.1 to 3.17 above is a "FATAL FLAW".
