PRE-QUALIFICATION FOR THE SUPERVISION, DESIGN, CONSTRUCTION AND SUPPLY OF EQUIPMENT IN THE WEST AFRICAN TEACHERS CONTINUOUS TRAINING COLLEGE, BIASE, MINISTRY OF EDUCATION, MICHEAL ANI SECRETARIAT, HOPEWADELL, CALABAR.

INTRODUCTION

The Government of Cross River State intends to undertake the establishment of Teachers Continuous Training College for West Africa located at Biase. This is aimed at providing quality Teacher Training and retraining including recertification and professionalizing teaching as obtained in the National Policy on Education, Nigeria. Following the above, applications are hereby invited from reputable and interested contractors with relevant experience, good track records on construction and financial capacity to tender for the construction of Teachers Continuous Training College in Biase under the following lots with Scope and details thus:

Lot 1: Design and construction of a standard administrative building to include Provost Block, Registry Block, and Bursary Department with staff offices, Admission Unit, 2No. Auditorium with offices, Lecture rooms with staff offices with toilets, installations, electrical works, plumbing and painting.

Lot 2: Design and Construction of 10No. Standard Lecture Halls with staff offices and toilets, 1 No. World Class Pavilion, a Training City Micro Finance Bank, installations, electrical works, plumbing works and painting.

Lot 3: Design and construction of standard male and female Hostels, staff quarters with boys Quarters, Clinics, refectories, road network linking the structures, and construction of main gate to the college, electrical works, plumbing and painting.

Lot 4: Design, construction and Equipping of Agricultural science Laboratory, Biology, ICT, Physics and Chemistry Laboratories to include standard laboratory tables and stools from a given design cupboards computers, reagents, chemicals and other laboratory equipment to include installations of solar panels and, electrical and plumbing works and painting.

Lot 5: Design and construction of sports centre to accommodate convocation Arena for the training college.

Lot 6: Design and construction of furniture to include standard School desk for students, Office tables, chairs, digital interactive board for all the lecture rooms and Offices

Lot 7: Design and Construction of 3No. 6 Classroom Blocks with Offices and toilet for Demonstration Junior Secondary School with Offices and toilets, design and construction of staff common room, male and female dormitories, design and construction of 2No. Laboratories for ICT and Basic Science, design and construction of refectory for the dormitories.

Lot 8: Site Surveys, Design of layout, site levelling and filling including perimeter fencing.

Mode of Procurement/Method of Obtaining Application Form the pre-qualification will be conducted through National Competitive Bidding (NCB) with Procedures as specified in the Cross River State Procurement Law and guidelines from Due Process and Price Intelligence Bureau, interested eligible contractors/Suppliers may obtain further information from the procurement officers, Ministry of Education Headquarters Calabar and obtain eligibility form on payment of N20,000 (Twenty Thousand Naira) only from 9am to 4pm Mondays through Fridays except on public holidays from the day of extension of this publication.

PRE-QUALIFICATION REQUIREMENTS INCLUDE THE FOLLOWING:

- Certificate of Incorporation from Corporate Affairs Commission
- Evidence of registration or renewal from Due Process and Price Intelligence Bureau, Cross River State
- Evidence of similar Jobs
- Audited financial statements of accounts for the last three years
- Evidence of adequacy of working capital for the contract
- Evidence of current Tax Clearance (that is the one expiring on 31/12/2018)
- Evidence of director s tax clearance
- Evidence of VAT remittances
- Company' s Profile with professional Qualifications of staff
- A signed letter of application for each of the lots applied for.
- Affidavit that no MOE Directors is a director, that all information given with respect to the advert are true and that none directors of the company has been convicted for any criminal offence including fraud and financial impropriety.
- All certificates used for the bidding exercise should be in coloured photocopies
- Evidence of registration with financial Reporting Council of Nigeria
- Evidence of PENCOM Registration
- Evidence of Industrial Training Fund (ITF) registration.

ADDITIONAL QUALIFICATION REQUIREMENTS

Verifiable documentary evidence of similar jobs successfully executed within the last five years. Such evidence shall be in form of valid letters of award, contract agreement and completion certificates or interim payment certificates where jobs are still in progress. Proven integrity of performed projects is an added advantage.

A margin of preference for eligible national contractors shall not be applied. Additional details are provided in the bidding documents.

The pre-qualified companies shall be published on the Notice Board of the State Ministry of Education, Calabar within two (2) weeks after the close of pre-qualification.
