(2.9) Certificate of compliance with Industrial Training Fund Amendment Act 2011 issued by the ITF or evidence of Exemption.

(2.10) Evidence of Registration on the National Data Base of Contractors, Consultants and Service Providers by inclusion of Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPP).

(2.11) Sworn Affidavit indicating that the Company is not in receivership, Insolvent or Bankrupt.

(2.12) Must not have any Director who has been "convicted in any Country for any criminal offences relating to fraud or financial impropriety".

(2.13) Evidence of photocopies of Memorandum of Article of Association.

(2.14) Bidders should accompany every bid with a disclosure whether any officer of the Board, former, present Director, and Shareholders has any pecuniary advantage in the Company.
