- vii. A letter of credibility from the bank as a customer that maintain an account in the bank
- viii. Evidence of Audited Account for 3 years
- ix. Evidence of compliance with pension reform act 2004
- x. Evidence of compliance with the provision of the industrial training fund amendment act as stipulated in section 6(1)-(3).
- xi. List of equipment and technology capacity
