3. **The HIV/AIDS Programme Development Project II, (Enugu State Agency for the Control of AIDS), (ENSACA) now invites sealed bids from eligible and qualified bidders for the Procurement of the following**

Bidders may bid for any or more lots and discounts offered for the award of combined lots will be considered in bid evaluation.

1. Bidding will be conducted through the **National Competitive Bidding (NCB)**, a procedure specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

3. **6. Qualifications requirements include:**

- Documentary Evidence of two contracts of similar nature and magnitude during the last five (5) years
- Audited Financial Statements for the last three (3) years to demonstrate the financial capability of the Bidder in terms of Profitability and adequate working capital.
- A Manufacturer's Authorization for equipment not produced by the company.

A margin of preference for eligible national contractors **shall not** be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non-refundable fee of N10,000.00 (Ten Thousand Naira) only. The method of payment will be by bank draft in favor of Enugu State HIV/AIDS Programme Development Project II or cash paid **into Enugu State HIV/AIDS Programme Development Project II, Draw-down Account No. 1012582241 at Zenith Bank PLC**.
