RE: FEDERAL CONSTITUENCY PROJECTS

I received your letters dated 8th and 15th, October 2014, where you called my attention to some of the projects I facilitated in 2014.

As a background information regarding the projects, it should be noted that each federal lawmaker in Nigeria always facilitate some projects yearly by way of constituency or zonal intervention projects. It should however be stated that NO senator implements, constructs, executes constituency projects himself or herself. Lawmakers cannot also short-list contractors. The awarding of projects to contractors, funding, implementation is basically at the instance of the executive arm of government via the MDAs.

As you may also be aware, Mr. President only assented to the 2014 budget in June 2014. It is after his assent that the budget became law and thus implementable (especially capital budget)

While I appreciate the advocacy programmes and activities of your organisation towards ensuring more accountability of the public servants to the people, I will urge you to concentrate more on putting pressures on the MDAs to hasten up their procurement processes. You should also beam your search-lights on the poor releases of funds for capital votes by the Ministry of Finance.

My commitment to the welfare and quality representation of the people of Ogun West remains unwavering. I have been following up, providing logistics where applicable and constantly interfacing with the respective MDAs, who are wholly in charge of implementing the constituency projects I facilitated.

Kindly find attached to this letter, the statuses of the projects you stated in your letters and my remarks for your perusal.
