- (v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate (2017);
- (v) Verifiable documentary evidence of at least three (3) similar jobs including Letter of Awards, Valuation Certificates and Job Completion Certificates in the last five (5) years;
- (vi) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal College of Education (Technical), Asaba or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

- (i) List of Plants/Equipment with proof of Ownership/Lease (where applicable)
 - (ii) The minimum turnover for the Lots1, 2 and 6, should be in line with the formula specified in the Standard Bidding Document (SBD) for Works published by the Bureau of Public Procurement;
 - (iii) Curriculum Vitae of Key Staff with their copies of professional qualifications
- (C)** The requirement for “evidence of VAT registration” ought not to have been included in the advertisement, as the request for Tax Clearance Certificate (TCC) has taken care of VAT;
- (D)** No bidder should bid for more than two (2) Lots;
- (E)** Closing date for submission and opening of Pre-Qualification is **Tuesday, 5th December, 2017**, time **12.00 noon** prompt at Federal College of Education (Technical), Asaba Board Room (Temporary Site).

- (vii) Evidence of VAT Registration;
- (viii) Evidence of audited account of the firm/company's financial details for the last three (3) years;
- (ix) Verifiable office and workshop address (es); NOT P.O.BOX but should include telephone number(s) of company Director(s);
- (x) Company's profile and evidence of relevant/similar project executed;
- (xi) Statement as to completion date of the project; and
- (xii) Sworn Affidavits

Arrangement of documents (in soft and hard copies) should follow the order in the list above appropriately numbered. Each parcel should have a table of content indicating the pages on which these items are to be found.

All applications for pre-qualification must be delivered in a sealed envelope marked "Application for Pre-qualification" at the top corner of the envelope and should be addressed to the Registrar, Federal College of Education (Technical), Asaba on or before **5th December, 2017**. Pre-Qualification documents received will be opened at **12.00 noon** on the closing date at the Board Room, Federal College of Education (Technical), Asaba (Temporary Site).
