(2.0) MANDATORY/ELIGIBILITY REQUIREMENT

- (a) Evidence of Registration with Corporate Affairs Commission (CAC) including form CAC2 and CAC7.
- (b) Evidence of Tax Clearance Certificate for the last three years valid till 31st December 2018; with minimum turnover of (N5,000,000.00).
- (c) Evidence of current Pension Compliance Certificate (2018).
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate (2018).

- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Valid till December, 2018.
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 01/01/2019 or Valid Certificate issued by BPP.
- (g) Evidence of Sworn Affidavit disclosing whether or not any officer of the relevant Committees of Michael Okpara University of Agriculture, Umudike or the Bureau of Public Procurement is former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all formation presented in its bid are true and correct in all particulars.
- (h) Company Audited Account for the last three (3) years (2015-2017)
- (i) Evidence of Financial capability to execute the project by submission of a reference letter from a reputable commercial bank indicating willingness to provide credit facility for the project when needed.
- (j) Company Profile with Curriculum vitae of key staff to be deployed for the project, including copies of their professional qualifications.
- (k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Award, Valuation Certificates, Job Completion Certificates and photographs of the project.
- (l) The list of Plants/Equipment with Proof of Ownership/Lease.
- (m) For joint Ventures/Partnership, Memorandum of Understanding (MOU) should be provided.

The letter head paper must bear the Names and Nationalities of the Directors of the company at the bottom of the page, duly signed by the authored officer of the firm.

Interested Contractors are required to prepare and submit their Pre-qualification/Financial Bid Documents in sealed separate envelope. To be clearly written at the top right hand corner of each envelope are: the Project Title, Lot Number, Contractor's Name and "Technical Bid" or "Financial Bid" as the case may be. Both envelopes shall be enclosed in a bigger envelope with the inscriptions at the top right hand corner of the envelope 2015/2016 TETFund Project Maintenance Intervention Title/Contractor's name and the envelope addressed to the Registrar, Room 214, Alex Ekwueme Building, Michael Okpara University of Agriculture, Umudike.

The Pre-qualification/Financial bid documents shall be dropped in a marked box at the Office of the Registrar **on or before 12:00noon on Monday, 10 December, 2018.**

(5.0) OPENING OF BIDS

The technical bids shall be opened immediately after the deadline for submission at **12:00noon on Monday, 10 December, 2018** in the Vice-Chancellor's conference room in the presence of the representatives of the bidding Companies and the general Public who wish to attend. In submitting the company's profile, please state clearly the company's full contact address, GSM phone number and E-mail address required for ease of communication. Pre-qualified Contractors shall be notified accordingly for the opening of their financial bids at a later date, while financial bids unsuccessful bidders will be returned un-opened.

(6.0) NOTE PLEASE:

Bidding will be conducted through the National Competitive Bidding (NCB) Procedure as specified in the Procurement art, 2007.

- (i) Interested bidders may obtain further information from the Procurement Officer MOUAU.
- (ii) Failure to satisfactorily fulfil these conditions as requested above shall result to invalidation of such bid.
- (iii) MOUAU shall reserve the rights to verify the authenticity of claims made by the bidder and reject any submission based on unverifiable information.
