**(1.0) INTRODUCTION:**

(vii) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/06/2019 or valid Certificate issued by BPP

(viii) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31<sup>st</sup> December 2018

(ix) Verifiable evidence of at least (3) similar jobs executed in the last 3 years supported with letters of award and commissioning.

(x) Activity description, client location, value of Job, status of the projects, practical completion certification etc

(xi) Verifiable evidence of equipment/plant relevant for the work where applicable with proof of ownership or lease.

(xii) Company's profile including CV/Qualifications of Key Personnel to be deployed on the job.

(xiii) Verifiable evidence of financial capability of the company by submission of reference letter from a reputable Commercial Bank in Nigeria indicating willingness to provide credit facilities for the execution of the project.

(xiv) Sworn Affidavit

disclosing whether or not any officer of the relevant committees of the Federal Medical Centre, Abeokuta or the Bureau of Public Procurement is a farmer or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars and

that neither the company nor its directors is undergoing any form of receivership, insolvency or bankruptcy.

(xv) For joint ventures, Memorandum of Understanding (MOU) must be attached; each of the companies forming the joint venture must fulfill all the eligibility requirements.

(xvi) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, the Registration

Number (RC) as issued by the Corporate Affairs Commission(CAC, Contact Address, Telephone Number (preferably GSM No), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm
