The University College Hospital, Ibadan in partnership with Access Bank has completed equipping the UCH-Access Bank Low Cost Fertility Centre, University College Hospital, Ibadan.

(2) INVITATION

The University College Hospital, Ibadan hereby invites eligible and competent professionals or organization already providing quality services in assisted conception and treatment of infertility to partner with the Hospital in the Protocols, Processes and Implementation of the UCH-Access Bank Low Cost Fertility Centre, UCH on a Management Contract arrangement.

(3) SCOPE

To amongst other things:

- (i) Provide technical support in the establishment of an Assisted Conception Unit at the University College Hospital Ibadan.
- (ii) Provide initial training for relevant health personnel working in the Assisted Conception Unit
- (iii) Oversee the initial take off of the Assisted Conception Programme
