(A) BACKGROUND

(1) The Government of Nigeria with support from the World Bank is rolling out the Innovations for Malaria Prevention and Control (IMPACT) project to address existing gaps in the coverage of malaria control interventions across the country. The project will be financed by a credit from the World Bank to the government through the National Malaria Elimination Program (NMEP) and State Malaria Elimination Programs (SMEPs) in 13 states.

(2) IMPACT aims to sustain and build upon global evidence and prior successes in malaria control in Nigeria. Therefore, the project takes a multi-pronged approach that prioritizes evidence-based, cost-effective interventions; leverages partnerships with non-state actors to expand the delivery of quality services; and adopts market-based solutions to ensure the availability, affordability and quality of anti-malaria commodities.

(3) The National Malaria Elimination Program and its state counterparts would like to employ consulting services to strengthen the delivery and promote the uptake of malaria prevention and treatment services especially in rural communities where the burden of malaria is the greatest. The NMEP and SMEPs intend to employ output-based approaches in contracting consulting firms otherwise known as "Consultants" with proven expertise and experience.

(B) OBJECTIVES:

(4) The contractor will be responsible for improving the following output indicators (an output indicator is defined here as one "that describes an action or event occurring to a household level beneficiary that is linked by strong evidence to a health outcome such as reduced malaria incidence):

1. i) Utilization of an LLIN by pregnant women the night before the survey;

2. ii) Utilization of an LLIN by children under five years of age the night before the survey; (iii) Use of correct malaria treatment (ACTs) among children under 5 with fever in the last two weeks;

(iv) IPTp (at least 3 doses) during a pregnancy in the last 1 year;

(v) SMC for children in Sahelian states during high transmission season;

(C) SCOPE OF WORK- SERVICES

(5) The proposed scope of work ("Services") includes:

(i) Managing logistics and last mile distribution of Long Lasting Insecticide Treated Nets (LLIN);

(ii) Employing strategies to ensure that families hang-up and use LLINs;

(iii) Procuring and distributing key anti-malaria commodities (ACT, RDT, SP+AQ, SP and Artesunate Injectable) to public sector facilities and private facilities;

(iv) Strengthening the case management skills of both public and private providers including the Integrated Community Case Management (ICCM)/Integrated Management of Childhood Illnesses (IMCI);

(v) Increasing the knowledge of households about the symptoms and appropriate treatment of malaria and improve their health seeking behavior early recognition of symptoms and prompt treatment;

(vi) Improving the malaria prevention behaviors of households including the use of Intermittent Preventive Therapy in pregnancy (IPTp) and Seasonal Malaria Chemoprophylaxis (SMC) in Sahelian states.

(6) The consulting services will be delivered in Tasks as follows:

(D) ELIGIBILITY		

To be shortlisted, the Consultant must meet the following, criteria including:

(7) Eligible consulting firms will apply for one Task each and must have an annual turn-over of at least Naira 120 million. However, firms may apply for more than one Task provided they demonstrate a sufficient annual turn-over in the last two years as outlined below:

Annual Turnover in last 2 years	Eligible number of Tasks firm may apply for
N120 million to N180 million or \$330,00 to US\$500,000	1 of Task 1-13
N180 million to N360 million or US\$500,000 to US\$1 million	Maximum of 2 of Tasksl-13

(8) Firms may apply as consortia of a maximum of three (3) firms. Firms with a turnover below the minimum threshold must apply as a consortium with no more than two (2) other firms of equivalent technical and financial capacity. In this instance, levels of turnover for consortia will be assessed as an aggregate of the turnover of all three entities. All consortium members must provide evidence that the selection criteria set out below have been met in a full. Alternatively, a firm with requisite turn over may, along with subcontractors; wish to apply as a consortium. In this case, the turnover of the lead partner will be assessed; however, sub-contractors must meet the minimum turnover requirement and as well as other selection criteria. In both instances, a lead partner who shall be the focal point for the expression of interest, bid and contractual agreement should the firm be successful, must be identified in the Expression of Interest.

(9) The National Malaria Elimination Program now invites eligible consulting firms ("Consultants") to indicate their interest in providing the tasks enumerated under Services. Consultants should indicate their preference for which state(s) they would like to work in, although such preferences may not be honored in the interest of achieving efficiency and ensuring competition. Consultants or consortia expressing interest in 2 Tasks may not have more than 1 Task from Tasks 1-10. Consultants or consortia expressing interest in 3 Tasks may not have more than 1 Task from Tasks 1-2, and 1 Task from Tasks 3-10.

(i) Evidence that the Consultant is a legal entity recognized in the domicile country with capacity to do business with Government;

(ii) Ability to provide services in project management, procurement, monitoring and evaluation.

(iii) Understanding of the health sector in Nigeria and the states in which it desires to work.

(iv) Ability to deliver primary health care services and community based programs.

(v) Proof of a solid track record of a minimum of three (3) years in health programs preferably in similar locales with evidence of success from independent data sources.

(vi) Demonstrated experience in successfully handling assignments similar in size during the last three (3) years including evidence of annual turn-over in keeping with the eligibility criteria described above.

(vii) Evidence of a local agent or a resident office in Nigeria

(10) Following the shortlisting process, Consultants will be selected using the Quality and Cost-Based Selection (QCBS) method in accordance with the procedures set out in the World Bank's "Procurement Regulations for IPF Borrowers" (Procurement Regulations) dated July 2016 (revised November 2017 and August 1, 2018) under the "New Procurement Framework (NPF), available at the World Bank website:
