REQUEST FOR PROPOSAL IN THE PRE-QUALIFICATION FOR SUPPLY OF 30 NO. MOTOR CYCLES, 3NO. 4WHEEL DRIVES, RENOVATION OF SOML (PFORR) OFFICE COMPLEX, REVITALIZATION OF 21 SELECTED PHCS IN KEBBI STATE

STATEMENT OF PURPOSE

The purpose of this Request for Proposal (RFP) is to solicit innovative and competitive proposals that will serve as a pre-qualification to reputable companies interested in undertaking public work, supplies and services on Saving One Million Lives (SOML) Programme for Results (PforR) as follows:

- (1) Procurement of 30 no. motor cycles
- (2) Procurement of 3no. 4wheel drive vans
- (3) Renovation of SOML office complex
- (4) Revitalization of 21 selected PHCs

(2) Consequently, the Kebbi State Ministry of Health on behalf of the Kebbi State Government now invites sealed prequalification documents from interested reputable, competent and eligible companies for the above work and services with the under listed requirements:

- (a) Evidence of incorporation with the Corporate Affairs Commission
- (b) Evidence of registration as contractor with the Evidence of registration with Ministerial Tenders Board, processing fee, locally based and resources, community and social responsibility
- (c) Company Financial Statement/ Audited account

- (d) Evidence of last 3 years Tax Clearance Certificate
- (c) Evidence of Financial Capability and Financial Support
- (d) Evidence of Qualified key technical personnel in the works and services
- (e) Evidence of verifiable similar projects execution in the past 3 years
- (f) VAT Registration and Evidence of past VAT remittance

(3) Bidding will be conducted through the Selective Bidding (SB) procedures specified in the Guidelines for the Kebbi State Price Intelligence and Public Procurement Bureau and are open to all bidders from Eligible Source as defined in the Guidelines. Notwithstanding, the Ministry reserves the right to accept or reject any pre-qualification document, and to cancel the bidding process and reject all bids, at any time prior to the award of Contract, without incurring any liability to the affected Bidder or bidders or any obligation to inform the affected Bidder or bidders of the grounds for the Employer's action.

(4) Interested eligible bidders may obtain further information from The Kebbi State Ministry of Health at the address given below from 9:00am to 4:00pm, Mondays through Thursdays and 9:00am to 1:00pm on Fridays.
