(1) PROJECT BRIEF

The University of Benin (referred to as the 'Sponsor") has received an 'Unsolicited Proposal' for the development of a PPP-based Ground Mounted Centralized Solar Photovoltaic independent Power Plant of 15MW with 5MWh Energy Storage System. The PPP Project objective is to provide reliable and cost-effective electricity to support Learning, Training, Research and Development in the University.

Following the receipt of the Unsolicited Proposal, to ensure transparency and competition, the concessionaire/investor will be procured using Swiss Challenge procurement method that requires that if the original project proponent is not the most responsive bidder, it will be given the right of first refusal to match the most responsive bid and win the concession. However, if it is unable or unwilling to match the most responsive bidder, the most responsive bidder would become the preferred concessionaire/investor.

(2) REQUEST FOR QUALIFICATION (RFQ)

Reputable private sector energy and power companies are invited to submit a Request for Qualification (RFQ) to undertake the Design, Finance, Build, Operate and Transfer (DFBOT) Concession for the 15MW Solar Photovoltaic independent Power Plant with 5MWh Energy Storage System. This RFQ is the qualification stage of the procurement process for the Project. Qualified parties shall execute a Non-Disclosure Agreement (NDA) and make a non-refundable payment of NGN N250,000 (Two Hundred and Fifty Thousand Naira) prior to being Issued the Request For Proposal (RFP) Bidding Documents.

(3) ELIGIBILITY CRITERIA & METHOD OF APPLICATION

Interested applicants should indicate their Interest by proving brief documentation structured into the following sections:

(3.1) ELIGIBILITY

- (i) Evidence of Company Registration with Corporate Affairs Commission (CAC) or its equivalent for foreign firms;

- (ii) Minimum of 8 years experience of technical and operational capabilities in power generating plants (design, engineering, operations, maintenance or ownership of any type of power project);
- (iii) Track records of developing, engineering, operating, maintaining and owning power generating plants of a cumulative size of up to 10MW of solar photovoltaic systems:
- (iv) At least three verifiable references/evidence of past performance;
- (v) Evidence of adequate financial resources to finance investment (interested applicants must have a minimum tangible net worth of N4.3 billion as shareholders equity contribution (shall consider combined revenue of three years from at members of a consortium).
