**(A) ADJUSTMENT TO ELIGIBILITY REQUIREMENT**

(i) Section 1.0 (vi) of the said Advertisement which directed Bidders to Provide VAT Certificate is no longer applicable.

(ii) Section 1.0 (viii) of the said Advertisement is now written as “Evidence of Compliance with Pensions Reforms Act, 2004 by inclusion of Compliance Certificate from the National Pension Commission”.

(iii) Evidence of financial capability/Reference Letter from a reputable Bank in section 1.0 (viii) of the said Advertisement is now written as a separate sentence.
