**Background**

- The strategic plan should clearly address sustainability of AFENET as an organization
- The gaps and challenges faced in implementation of the plan should be well articulated and mitigation measures clearly spelt out.
- The existing financial plan will have been reviewed to determine what has been achieved, gaps and challenges faced. Realistic projections and timings will have teen proffered in the reviewed financial plan.
