Request for Expressions of Interest

This request for Expressions of Interest follows the general procurement notice for this project titled “P123513-NG-III Nat’l Urban Water Sector Reform” that appeared in DG market publication of April 17, 2015.

The Ekiti State Government through the Federal Republic of Nigeria has received financing from the International Development Association (IDA) toward the cost of the Third National Urban Water Sector Reform Project, and intends to apply part of the proceeds of this project to cover eligible payments under the contract for the following consultancy services:

The primary objective of the assignment is to employ bathymetric means to obtain accurate elevation area – storage characteristics of the reservoirs. This assignment will produce as a deliverable, a bathymetric survey report comprising raw data, contour maps, longitudinal profiles, storage curves, sediment deposit estimates, etc.
