- Applicants must demonstration that they have presences in the LGA/States
- Applicants must, have been legally registered in Nigeria before 01 January 2016
- Their current organizational structure (organogram)
- Women-led organizations are strongly advised to appl

SELECTION CRITERIA:

In addition to the eligibility criteria, successful applicants must:

- Have proven thematic expertize on SRH
- Have satisfactory past performance reference
- Have verifiable financial and operational management capacity
- Be able to provide their most recent audited financial statement or certified annual financial report

SUBMISSION OF APPLICATIONS

Applications should include the following:

- A brief Expression of Interest on letterhead of the organization
- Key contact personal, their position(s), and contact details
- A copy of National, State, or Local Government Registration (as appropriate); and
- Address of a physical office in one of the three focus states.
