I am directed to acknowledge receipt of your letter dated 12th September 2014 but received on the 18th September, 2014 on the above subject matter and to inform you that the awards under the 2014 Appropriation are still under process. The above contracts vis Construction of New Access Road to Kanidinma Cottage Hospital in Onicha Uku; and Construction and Equipping of Health Centre at Ivrogbor, Isoko South, Delta State are yet to be awarded.

In view of this and in line with section 15 (1)(a-c) of the FOIA, the Agency cannot release the information concerning the projects till after the completion of the 2014 procurement process.

However, in respect of the second request above, the contract for the completion of the ongoing access road construction to Kanidinma Cottage Hospital (Phase 2) was awarded to OMASIP GLOBAL NIGERIA LTD for the cost of N65,581,676.00

inclusive of taxes. The contract award was issued to the company on 17th March, 2014.

For the same reason, your request listed as items 1, 3, 4, 5, 6, 7, & 8 of paragraph 2 of your letter cannot also be granted. We wish to draw your attention to the fact that this year's procurement process commenced late due to late release of the budget. Consequently the procurement process is still on going and to release the information you are asking for at this stage will unduly prejudice the interests of other bidders.

However, in respect of item 2, photocopies of the Daily Trust newspaper of June 20, 2014 and August 29, 2014 showing advertisement of invitation for bids published by the Agency are hereby attached.
