- (5) To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

- (6) Ownership of existing facilities/infrastructures at the Free Trade Zones of Onne and Warri Ports.

# (4.0) NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development (NOGICD) Act and also provide the following requirements:

- Only Nigerian registered entity having greater than 51% Nigerian shareholding shall bid
  for this work scope. Tenderer shall provide evidence that entity is a Nigerian-registered
  company. Submit certified true copies of CAC forms 10, 02 & 07 (or its equivalent; CAC
  2.3, 2.4, 2.5, etc.) and other evidence of entity's incorporation, shareholding & ownership
  structure Nigeria. Tenderer shall provide evidence of registration on the NCDMB NOGIC
  JQS and DPR certificate.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Provide a Nigerian Content execution Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether
  contracted directly or under subcontract agreements) with names arc addresses including
  evidence of well-equipped offices and workshop; attach experience of such patronage.
- Provide detailed description of the location of in-country facilities and infrastructures (Administrative & Technical offices) in Nigeria to support this contract.
- Tenderer shall comply with the latest approved version of NCDMB HCD guideline by committing (via a letter of undertaking) to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainee(s) or other approved NCDMB training institution(s).
- Tenderer shall provide evidence of Category C NCEC certificate and or NCEC Category 1,2, or 3 Services and Support (SS) group NCEC to demonstrate at least 50% ownership of the equipment not limited to Forklifts, Trucks pipe handlers, Cranes to be utilized in executing the work scope.
