(1) INTRODUCTION

This Specific Procurement Notice follows the General Procurement Notice (GPN) for 2017 capital and recurrent projects published on Monday 21st August, 2017 in Authority Daily Newspaper, Blueprint Newspaper, Federal Tenders Journal and on the TETFund website. The Tertiary Education Trust Fund (TETFund), in compliance with the provisions of the Public Procurement Act (2007), hereby invites eligible Contractors and Suppliers to submit Technical and Financial bids for the following:

- (ii) Evidence of Current Tax Clearance Certificate for the past 3 years 2014, 2015 and 2016;
- (iii) Evidence of Current Pension Compliance Certificate (2017);
- (iv) Evidence of current Industrial Training Fund (ITF) Compliance Certificate (2017);
- (v) Evidence of three (3) similar works executed in the past five (5) years including Letters of Awards, Valuation Certificates and Job Completion Certificates;

- (vi) Audited Accounts for the past three (3) years (2014, 2015 & 2016);
- (vii) Company Profile with C.V of Key Staff and copies of their professional qualifications;
- (viii) Evidence of financial capability to execute the project including Bank Statements and Reference Letter from reputable commercial banks indicating willingness to provide credit facility for the execution of the project when needed;
- (ix) Eligible firms for Lot 1 should have a minimum turnover of N150 Million Naira per annum; while bidders for Lot 2 and Lot 3 eligible firms should have a minimum turnover of N100Million and N250 Million Naira per annum respectively;
- (x) A sworn Affidavit disclosing whether or not any officer of the relevant Committees of the Tertiary Education Trust Fund or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars
- (xi) Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2018 or Valid Certificate issued by BPP.
- (xii) Bidders for Facility Management Service should accompany their submission with the evidence of membership with Environmental Health Officers Registration Council of Nigeria (EHORECON).

(2) COLLECTION OF STANDARD BIDDING DOCUMENTS

All Bidders and/or their Representatives, Relevant Professional Bodies and NGOs are invited to witness the Public Opening of Bids. Please note that submission of Bids via posting, e-mail or other electronic medium is not acceptable.

Bidders would not be allowed into the Fund for submission of Bids at exactly **12:00pm on 6th March, 2018.**
