All eligible and interesting bidders should buy tender for the Construction of 80no. blocks of two classrooms Islamiyya Type, 2no. blocks of two classrooms with office (SUBEB Type) and Renovation of 1no. Teachers' Lodge.

(p) Note that Bid opening shall be performed on **18 September, 2018 by 12.00 Noon**, at SUBEB Conference Room, Dutse, Jigawa State in presence of bidders or their representatives.
