(1.0) INTRODUCTION

(2.0) SCOPE OF WORK

The scope of the contract covers the supplies of all PPE categories for use in SPDC Operations:

- (a) Garments – fire retardant coveralls;
- (b) Foot wear – pull up and ankle high safety shoes;
- (c) Head protection – hard hats;
- (d) Accessories – non-fogging anti-scratch goggles, gloves , ear muffs and specialized PPE like, respirators, fall protection devices etc

(3.0) MANDATORY REQUIREMENTS

(1) To be eligible for this tender exercise, interested contractors are required to be pre-qualified as essential service vendor in the NJQS product category 1.16.02

Safety and Protection Equipment/Products, Life Boats/ Rafts and Escape route in Nipex Joint Qualification System (NJQS) data base. Only successfully pre-qualified supplies in this category will receive Invitation to Tender (ITT).

(2) To determine if you pre-qualified and view product/service category you are listed for, open www.nipex-ng access NJQS with your login details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.

(3) If you are not listed in a product/service category and you are registered with DPR to do business, contact NipeX office at 8-10 Bayo Kuku, Ikoyi, Lagos with your DPR certificate as evidence for necessary update.

(4) To initiate the JQS pre-qualification process, access www.nipex-ng.com to download the application for further action.

(5) To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

(4.0) NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrated strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and also provide the following requirements.

- Demonstrated that the entity is a Nigerian registered company with greater than or equal to 51% Nigeria shareholding. Furnish details of company ownership and shareholding structure. Also submit clear photocopies of your CAC Forms C02 and C07
- Provide evidence of what percentage of your Key management positions held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigerians and those by Nigerian resources relative to total work volume
- Provide a Nigerian Content Execution Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian Companies and personnel that would be involved in executing the work. Also, provide details of Nigeria Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and address including evidences of well-equipped offices and workshop; attach past experience of such patronage
- Demonstrate in line with the NCDMB Human capacity development training, a training plan to train Nigeria personnel at the back of this service.
- Location of in-country facilities (Storage, workshops, repair & maintenance facilities)
- Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and services.
- Provide evidence of Nigeria Content Equipment Certificate from NCDMB for manufacturing capability of but not limited to Garment, Foot wear, head protection hard hats etc.
- Provide evidence of registration with NCDMB JQS

(5.0) CLOSING DATE

Only Tenderers who are registered in the NJQS product/category as at **6, June 2019** being the advert close date shall be invited to submit bids.

(6.0) ADDITIONAL INFORMATION
