## (1) INTRODUCTION

Total Upstream Nigeria Limited (TUPNI) operator of the OML 130 invites interested and reputable indigenous suppliers with suitable personnel, equipment and relevant experience for consideration for inclusion in the tenderer's list for subject tender opportunity.

# (2) Brief description of Work Scope and Specifications

The expected duration of this contract is two (2) years plus two (2) optional duration of one (1) year each.

The Well Intervention SERVICES shall include the provision of PERSONNEL, equipment, materials, consumables and operational support on mobile drilling units operating on OML 130 deep offshore field development field for Intervention Operations in the wells. In addition, SERVICES shall include all required onshore support to ensure the realisation of planned scope of intervention. The SERVICES cover the provision of Pumping, Coiled Tubing (CT), Nitrogen, Downhole tools and Chemicals for the purpose of intervention in a well.

The set of coiled tubing and nitrogen SERVICES equipment is to be used as a contingency during completion operation, intervention or workover operation and mobilized when required and ready for use on board the vessel (rig up or not).

#### CONTRACTOR'S obligations shall include (but not limited to):

- Onshore preparation of equipment (including COMPANY supplied items): Inland transportation and storage, assembling, testing, loading out the equipment and COMPANY supplied items for offshore operations.
- Provide 1.75" and 2.125 " Coiled Tubing (> 6500m) with 90K and /or 125K psi min. yield, continuously milled, tapered type, and 10,000 psi Standard Service. And other Coiled Tubing Equipment and downhole tools specified by COMPANY.
- Ensure that all required equipment is available in a timely manner, fully prepared, tested and commissioned as required and in first class condition in accordance with the requirements of the applicable operating manuals, operating instructions and of the latest regulations.
- Ensure that all equipment and products shipped offshore are packaged and slinged in accordance with COMPANY'S requirements.
- Providing specialist assistance offshore during drilling/completion or well intervention operations.
- Provide the SERVICES with PERSONNEL having the required experience, qualification and valid training according to CONTRACTOR qualification, training policies and in accordance with COMPANY requirement.
- Design of service for the execution of all Coiled Tubing related well intervention operations.

- Prepare and submit to company a Coiled tubing engineering, operation and contingency databook with detailed information and design of services for all coiled tubing related operations including proposed BHA schematics.
- Providing an Engineering following-up during the well intervention or drilling/completion period – analyse the problems encountered in the delivery of SERVICES, propose and implement corrective measures to avoid problem of reoccurrence and propose, when practical, new procedures, tools or equipment that would improve the operational and HSE performance.
- Post-offshore operation support: redress and storage of equipment, post operations review meetings.
- Importation/exportation and all related custom activities and expenses.
- Providing the SERVICES in a safe and environmentally responsible manner in accordance with CONTRACTOR'S own and COMPANY'S requirements and applicable regulations.
- Provision of back up equipment, spare parts and consumables necessary for the operation.
  Report operations (incl. End of intervention report) and perform post analysis of BREAKDOWN or EQUIPMENT & SERVICE non conformance

### (3) MANDATORY REQUIREMENTS

- (a) To be eligible for this tender exercise, interested suppliers are required to be prequalified in the 3.04.18 Well Overhauling / Stimulation Services Hydraulic, Stimulation, Coiled Tubing / Nitrogen Services, Pumping Services category of the NipeX Joint Qualification System (NJQS). All successfully pre-qualified suppliers in this category will receive an Invitation to Technical Tender (ITT).

- (e) To be eligible, all tenders must comply with the Nigerian content requirements in the NipeX system.

#### (4) Nigerian Content Requirement

TUPNI is committed to the development of the Nigerian Oil and gas business in compliance with the Nigerian Content Act 2010 for Nigerian Content Development.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian oil and gas industry shall be consistent with the level set in the Schedule of the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (The Board)

Tenderer(s) shall comply with all the provisions of the Nigerian Content Act that relate to this advert and in particular comply with the minimum Nigerian Content percentage for the scopes which are covered in the Schedule of the Act. This also includes and any other requirement that may arise from time to time not explicitly stated in this advert, but which apply to the services in fulfillment of the Nigerian Content Act, in the submission of their Tender.

Failure to fully comply with the Nigerian Content Act or demonstrate commitment to Nigerian Content Development Policy of the Nigerian government shall result in the disqualification of the tenderer from the bidding process.

### As part of their submissions, Tenderer shall:

- (a) Demonstrate that the entity is a Nigerian indigenous company having greater than or equal to 51% Nigerian shareholding in the registered company, by providing details of company ownership and shareholding structure (form C02 and C07). Also provide evidence of registration on NOGICD JQS
- (b) Tenderer shall provide detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, technical office, and administrative space, storage, workshop, assembly area) in Nigeria to support this contract
- (c) Submit Tenderer's corporate organizational and project/contract specific organogram for all key personnel not limited to Intervention Services Manager, Intervention Services Coordinator, Engineer, Supervisor, CT Operator, etc. CVs of all personnel as listed in the project organogram should be submitted. For any position to be occupied by expatriate, tenderer shall provide evidence to obtain expatriate quota approval granted by NCDMB before any expatriate is deployed to execute rhis work scope"
- (d) Tenderer shall provide evidence (Purchase receipt, Bill of Landing etc.) of at least 50% Nigerian ownership of equipment not limited to Combi BOP Stack, 1.75" & 2.125" CT, CT reel, Power Pack, Control Cabin, Injector Head, etc to execute this work scope.
- (e) Tenderer shall provide evidence of Valid category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board in respect of ownership of equipment to be utilized on the project.
- (f) In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Project-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- (g) Tenderer shall provide evidence of Binding MOA with Nigerian companies for procurement items to executing of the work scope.

**NOTE**: Failure to comply with the provision of the Nigerian Content Act 2010 or to demonstrate commitment to the development of the Nigerian Content Policy shall result in the disqualification of the tenderer from the bidding process.

## (5) ADDITIONAL INFORMATION

- (a) Only Nigerian Indigenous service companies having verifiable Nigerian equity shareholding of 51% and above shall submit bids for this tender.
- (b) Failure to provide any of the listed documents or information may automatically disqualify the tenderer.
- (c) All costs incurred in registering and prequalifying for this and other service categories in NJQS shall be borne solely by the Contractors/suppliers.
- (d) This advertisement shall neither be construed as any form of commitment on the part of TUPNI to award any contract to any company and/or associated companies, subcontractors or agents, nor shall it entitle pre-qualified companies to make any claims whatsoever, and/or seek any indemnity from TUPNI and/or any of its partners by virtue of such companies having been pre-qualified in NJQS.
- (e) The ITT and any further progression of this tender shall be via NipeX portal.
