(1.0) INTRODUCTION

Mobil Producing Nigeria Unlimited (MPN) operator of the NNPC/MPN Joint Venture (JV) plans to engage competent and qualified Companies to provide Drill Stem Testing/Tubing Conveyed Perforating Equipment and Services for its 2020 to 2022 development Drilling and Workover Program operations on its offshore location(s) in NNPC/MPN JV acreages. Anticipated contract term is two (2) years with an additional one (1) year optional period.

An open competitive tendering process through the NipeX portal will be adopted and a contract will be awarded to more than one bidder at the lowest responsive evaluated price/rates.

(2.0) SCOPE OF WORK

The scope of work shall involve provision of personnel, Services, equipment, materials and consumables for Drill Stem Testing/Tubing Conveyed Perforating operations on low pressure (<5000 psi surface working pressure) and high pressure (>5000 psi surface working pressure) wells located on fixed platforms in offshore Nigeria (water depth between 100-300ft MSL).

These Drill Stem Testing/Tubing Conveyed Perforating services will be required during normal exploration, completion and workover operations.

Equipment and services will include, but not be limited to, tubing conveyed perforating guns (Charges and Carriers), Mechanical/Hydraulic firing system, Gun Release Mechanisms (shoot and drop / one trip systems) downhole single & multi cycle tester valves, downhole single & multi-cycle circulating valves, reverse circulating valves (including single shot rupture valves), down hole memory gauges (bundle carriers), slip joints, safety joints, hydraulic jars, surge assemblies, retrievable squeeze / TCP packers, Packer by-pass equipment, surface control head / choke manifold system, and various downhole tools/assemblies typical for this type of operation and all other ancillary

equipment required for a fully functional and operational Drill Stem Testing and Tubing Conveyed Perforating.

Prior to mobilization, all of Contractors equipment and materials must be inspected prepared, marked and documented in accordance with all applicable Contractor Buyer and regulatory standards and specifications. Inspection documentation must be approved by Buyer prior to mobilization. Serviceability and strength of materials and Equipment must meet or exceed industry standards and contract specifications.

Contractor's responsibilities shall include but are not limited to the following:

- (i) Project Coordination (including Project Management and Job Planning System)
 - (a) Contractor shall have all facilities, equipment, and personnel prepared for MPN's
 - (b) All services shall be undertaken using current industry best practices and in compliance with any specification or recommendations outlined in this document and subsequent attachments hereafter.
 - (c) Contractor shall comply and carry out services in accordance with all applicable laws, regulations, Buyer held permits and Buyer policies unless dispensation has been authorized in writing from originating agency and deviation is approved by Buyer Contractor is responsible for obtaining all required permits for equipment and hazardous (radioactive, explosive, etc.) materials required in performing the Services
- (ii) Onsite Supervision including but not limited to:
 - (a) Liaison with all affected Rig and Platform personnel as appropriate.
 - (b) Coordination of all services supplied.
 - (c) Equipment rig up, test and operation.
 - (d) Provide adequate inventory of equipment, spare parts, materials, and consumables to ensure uninterrupted services.
 - (e) Provision of well-site data as requested by Company's representative(s).
 - (f) Preparation and distribution of end of well reports,
- (iii) Technical support including but not limited to:
 - (a) Ensuring all equipment is suitable in design and condition for the anticipated well conditions.
 - (b) Providing recommendations on test string design.

- (c) Supply all ancillary equipment required for Drill Stem Testing/Tubing Conveyed Perforating Equipment Services.
- (d) Performing perforating gun performance prediction.
- (e) Rig and Platform Surveys to establish equipment needs equipment layout and utility requirements.
- (iv) Perform the Work according to the SHE Management System in place for the Nigerian government and/or ExxonMobil Company (Company).
- (v) Perform the Work according to the requirements of the approved Quality Management System.

(3.0) MANDATORY REQUIREMENT

(a) To be eligible for this tender exercise, interested Tenderers are required to be prequalified in the 3.04.26 (Drill Stem Testing/Tubing Conveyed Perforating Equipment end Service) category in NipeX Joint Qualification Scheme (NJQS) database, successfully pre-qualified suppliers in this category will receive Invitation to Technical Tender (ITT).

(b) To determine if you are prequalified and view the product/service category you are listed for: Open <http://vendorsjqs.com> and access NJQS with your log in details, click on continue Joint Qualification scheme tool, click check “my supplier status” and then click supplier product group.

(c) if you are not listed in this product/service category and you are registered with DPR, please contact NipeX office at No. 8 Bayo Kuku Street, Ikoyi Lagos with your DPR certificate as evidence for verification and necessary update.

(d) To initiate the JQS pre-qualification process, access www.nipex-ng.com to download application form, make necessary payments and contact NipeX office for further action.

To be eligible, all tenders must comply with the Nigeria Content requirements in the NipeX system.

(4.0) NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the Schedule to the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (NCDMBMB).

MPNU requires their Contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the NCDMBMB.

Nigerian Content (NC) in the Nigerian oil and gas industry is defined as:

“The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry.”

“Nigerian company” is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Tenderers shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

As part of their technical tender submissions, Tenderers shall:

- (a) Provide a description of its committed infrastructure (administrative/technical offices, TCP facility with approved bunker) in Nigeria to support this contract
- (b) Evidence that a minimum of 50% of all equipment deployed to work by multinational and international companies are owned by the Nigerian subsidiary.
- (c) Submit certificate /permit for In-country capacity to carry out Drill Stem Testing/Tubing Conveyed Perforating Equipment and Services.
- (d) Provide project specific organogram showing names and nationalities of key personnel.
- (e) Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) including Memorandum and Article of Association. For Nigerian company in alliance with a foreign company or multinational, submit evidence of binding agreement of the alliance duly signed by the CEO's of both parties with each party's responsibilities clearly stated.
- (f) Submit a plan on how it intends to provide Human Capacity Development and Personnel Training
- (g) Provide evidence of Category C NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring in respect of DST-TCP equipment.

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in Tenderer's disqualification.

(5.0) CLOSE DATE

Only prequalified and LIVE suppliers under the stated product code 3.04.26 (Drill Stem Testing/Tubing Conveyed Perforating Equipment and Service) category in NipeX Joint Qualification Scheme (NJQS) database as at **Thursday, October 31, 2019** being the advert closing date shall be invited to submit Technical Bids.

(6.0) ADDITIONAL INFORMATION

(a) Interested suppliers must be prequalified for this product/service category in NJQS

(b) Full tendering procedure will be provided only to contractors that have been successfully prequalified in NJQS

(c) This advertisement shall neither be construed as an Invitation to Tender (ITT) nor a commitment on the part of MPN to award a contract to any supplier and/or associated companies, sub-contractors or agents

(d) This advertisement shall not entitle prequalified companies to make any claims whatsoever, and/or seek any indemnity from MPN and/or its partners by virtue of such companies having been prequalified in NJQS

(e) All costs incurred in registering and prequalifying for this and other product/service categories in NJQS shall be borne solely by suppliers
