- To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

(3.0) NIGERIAN CONTENT REQUIREMENTS

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development Act and provide the following requirements:

- Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies evidence or plans of physical operational presence and set-up in Nigeria.
- International or multinational company working through a Nigerian subsidiary must demonstrate that a minimum of 50% of equipment to be deployed for execution of work shall be owned by the Nigerian Subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary
- Furnish details of company ownership and shareholding structure. Also, submit clear photocopies of your CAC Forms CO2 and CO7
- Provide evidence of what percentage of your management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigerian and those by Nigeria resources relative to total work volume
- Provide a Nigerian Content Plan providing a detailed description of the role, work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also, provide details of Nigeria Content focal point or manager.
- State proposed total scope of work to be conducted by Nigeria personnel (whether contracted directly or under subcontract agreement) with names and addresses including evidences of well-equipped offices and workshop; attach past experience of such patronage

- In line with the NCD Human Cpacity Development Initiative, Bidder shall commit to providing project specific training, man-hour, budget, skill development and understudy plan for Nigerian Personnel utilizing OGTAN registered trainee(s) or other approved NCDMB training institution(s)
- Location of in-country facilities (Storage, workshops, repair & maintenance facilities and testing facilities)
- Contractor must be willing and able to provide evidence of maximization of made in Nigeria goods and service
