INTRODUCTION (1)

Mobil Producing Nigeria (MPN) Unlimited, Operator of NNPC/ MPN Joint Venture, hereinafter

referred to as Company plans to engage qualified contractors for the Provision of General

Maintenance Services to support JV Operations topside facilities located within the NNPC/MPN

Joint Venture acreage for an anticipated contract term of five years and a two year optional

extension period and is expected to commence in the third quarter of year 2019.

BRIEF DESCRIPTION OF THE SCOPE OF SERVICES

The scope of work which shall be provided shall include but not limited to the provision of

personnel, materials and supervision required for general maintenance services for MPN JV

Operation's onshore and offshore facilities from water line to topside in line with ExxonMobil

standards.

Contractor shall carry out the listed activities:

Maintenance activities at terminals and production facilities including the FSO (Yoho) (A)

(B) Management of teams performing maintenance activities

(C) Plan and schedule maintenance activities

Responsible for moving her personnel to MPN logistics take off locations e.g. Helipads,

Onne ports, etc.

- (E) Reporting, including the updating of Computerized Maintenance Management System (CMMS) and related documentation
- (F) Supply of tools, equipment and materials required for Operations and Maintenance Services
- (G) Management of Subcontractors to support service provision

Specific maintenance activities to be performed in this contract shall include Preventive, Corrective and Predictive Maintenance.

These services shall be provided by the Contractor who should have proven competencies in the following areas below:

- High level maintenance and inspection knowledge, practices and experiences in preventive and corrective maintenance for onshore and offshore oil and gas facilities.
- Contractor shall have resources with demonstrated expert level skills in Mechanical, Instrument, HVAC and Electrical systems maintenance required for the maintenance of some equipment groups including; instrumentation, pumps, metering system, electrical motors, generators, electrical distribution, gas turbines, instrument/gas compressors, gas and diesel engine, piping structure, HVAC units etc.
- The Contractor shall have the capacity to provide services involving lube oil testing, torqueing and hot bolting, tank maintenance, pipe wrapping, insulation and lagging installation, piping/structural welding and fabrication, nitrogen purging, scaffolding and rigging services, risk based coating, evacuation of hazardous and non-hazardous waste, calibrations and recertification of instrument and metering systems, marine operations, and maintenance of associated equipment's and necessary OEM services.
- Capability to provide operational equipment including Cranes, Electrical/diesel pumps, Compressors, and Generators of various capacities.
- Ownership of a well-established office complex and adequately structured organizational framework and operational processes will also be required. The contractor should be able to rapidly establish a standard operational office within MPN JVO service area on contract award.
- Established and functional competency assurance programs that ensures that contractor personnel have the knowledge and skills to maintain oil and gas facilities in a safe and reliable manner.

To be successful in this tender exercise, interested contractors are required to have delivered broad coverage GMC service in O&G industry previously.

(3) MANDATORY REQUIREMENTS

- (A) To be eligible for this tender exercise, interested contractors are required to be prequalified in the Management and Operations, including Production Supervision of all Facilities, Engineering, Modification and Maintenance Services for Site/Platform Tank Product Group 4.06.02 in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified Suppliers in this category will receive Invitation to Technical Tender (ITT).
- (B) To determine if you are pre-qualified and view the product/service category you are listed for: Open www.nipex-ng.com and access NJQS with your log in details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click Supplier product group.
- (C) If you are not listed in a product/service category but you are registered with DPR to do business, contact NipeX office at 8/10 Bayo Kuku road, Ikoyi Lagos with your DPR certificate as evidence for verification and necessary update.
- (D) To initiate the JQS pre-qualification process, access <u>www.nipex-ng.com</u> to download application form, make necessary payments and contact NipeX office for further action
- (E) To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

(4) NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the Schedule to the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

MPN requires their Contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the NCDMB.

Nigerian Content (NC) in the Nigerian oil and gas industry is defined as:

"The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry."

"Nigerian company" is a company formed and registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Bidders shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

As part of their submissions, Bidders shall:

- (1) Provide a description of its committed infrastructure (asset, equipment, technical office, and administrative space, storage, workshop, assembly area, repair, and maintenance, testing, laboratory, etc.) in Nigeria (offices, equipment etc.) to support this contract.
- (2) Evidence that 50% of all equipment deployed to work are owned by Nigerian
- (3) Provide evidence of company Ownership Structure form C02 and C07, registration on NOGIC JQS, DPR certificate.
- (4) For foreign companies and multinational in alliance with a local company, submit evidence that the local company is an indigenous company and the binding agreement of the alliance duly signed by the CEOs of both parties
- (5) Submit a plan on how it intends to give first consideration to services provided from within Nigeria, to meet the requirements of the NOGICD Act.

- (6) Demonstrate key Management positions that are Nigerian Nationals and the percentage of the Company total workforce (direct and in-direct employees) that are Nigerians
- (7) Submit a plan on how it intends to provide Human Capacity Development and Personnel Training
- (8) Provide evidence of application for NIGERIAN CONTENT EQUIPMENT CERTIFICATE (NCEC) issued by Nigerian Content Development and Monitoring Board (in respect of any components, spares, equipment, systems and packages to be used on the project

Bidders' failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in Bidder's disqualification.

Only bidders who are registered with Product Group 4.06.02 in NipeX as at **4:00pm on Friday**, **22 February**, **2019**, being the advert close date shall be invited to submit Technical Bids

(6) ADDITIONAL INFORMATION
