(1) INTRODUCTION

Mobil Producing Nigeria Unlimited (MPN), operator of NNPC/MPN Joint Ventures plans to engage the services of competent and qualified firms for the provision of Offshore Construction Support (OCS) for the Offshore Projects Enabling Contracts (OPEC). The anticipated contract term is for a period of four (4) years with a one (1) year optional extension period.

(2) SCOPE OF WORK

The scope includes provision of required vessels and associated equipment and services for the purpose of executing projects under the OPEC at various Company locations within Nigeria. The OPEC-OCS tender package will consist of the following Three (3) Tenders:

(3) MANDATORY REQUIREMENTS

- (A) To be eligible for this tender exercise, interested bidders are required to be prequalified in NipeX Joint Qualification Scheme (NJQS) database under the required Category Code(s) as specified above. For "Category 3 FIV & DSV", bidders prequalified for both NJQS categories will be eligible. All successfully prequalified suppliers in these categories will receive Invitation to Technical Tender (ITT).
- (B) To determine if you are prequalified and view the product/service category you are listed for: Open vendors.nipex-ng.com and access NJQS with your log-in details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.
- (C) If you are not listed in a product/service category you are registered with DPR to do business, contact NipeX office at No. 8 Bayo Kuku Street, Ikoyi, Lagos, with your DPR certificate as evidence for verification and necessary update.
- (D) To initiate the JQS prequalification process, access <u>www.nipex-ng.com</u> to download an application form, make necessary payments and contact NipeX office for further action.

(E) All contractor's vendors list to be utilized and deployed for the project procurement plan, contractor procured items and the sub-contracting plan shall be required to be approved by NCDMB

(4) NIGERIAN CONTENT

Company is committed to the development of the Nigerian Oil and Gas business in compliance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

As from the commencement of this Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be consistent with the level set in the Schedule to the Act and any other targets as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

MPNU requires their Contractors to comply with the Act, its attached Schedule and any applicable regulation developed by the NCDMB.

Nigerian Content (NC) in the Nigerian oil and gas industry is defined as:

"The quantum of composite value added to or created in the Nigerian economy by a systematic development of capacity and capabilities through the deliberate utilization of Nigerian human, material resources and services in the Nigerian oil and gas industry."

"Nigerian company" is a company registered in Nigeria in accordance with the provisions of Companies and Allied Matters Act with not less than 51% equity shares by Nigerians.

Tenderers shall consider Nigerian content as an important element of their overall project development and management philosophy for project execution.

In the course of tendering and as part of their submissions, tenderers shall be requested to:

- (a) Provide a description of its committed infrastructure (asset, equipment, technical and administrative office(s), inspection tools, etc.) in Nigeria to support this contract and evidence that a minimum of 50% of all equipment/tools deployed to work by multinational and international companies are owned by the Nigerian subsidiary.
- (b) Demonstrate that its entity is a Nigerian registered company, defined as a company registered in Nigeria in accordance with the provision of Company and Allied Matters Act. Provide details of its Ownership Structure. Submit certified true copies of CAC form (C02 and C07) including Memorandum and Article of Association. For Nigerian company in alliance with a foreign company or multinational, submit evidence of binding agreement of the alliance duly signed by the CEO's of both parties.
- (c) Submit a plan on how it intends to give first consideration to goods and services provided from within Nigeria, to meet the NC target set for the program in line with the requirements of the NOGICD Act.
- (d) Demonstrate key Management positions that are Nigerian Nationals and the percentage of the Company total workforce (direct and in-direct employees) that are Nigerians
- (e) Submit a plan on how it intends to provide Human Capacity Development and Personnel Training
- (f) Tenderer shall provide evidence of Nigerian content Equipment certificate NCEC issued by the Nigerian Content Development and Monitoring Board (in respect of any components, spares, equipment, systems and packages) that will be used for these work scope
- (g) Tenderer shall ensure that for marine vessels not limited to accommodation vessels, Main installation Vessels, Field installation vessels, Tugs, ROV, Diving Support Vessel, etc, first consideration shall be given to Nigerian vessels owned by category A/AA vendors and duly categorized on the latest NCDMB NOGIC JQS marine vessel categorization.

Tenderer's failure to comply with the NOGICD Act or demonstrate commitment to Nigerian Content development will result in Tenderer's disqualification.

(5) CLOSE DATE

Only tenderers who are registered and LIVE with NJQS Product category: 3.08.04 (Accommodation Platforms / Vessels) & 3.08.01 (Tugs / ROV/ Support/ Diving Support) as at **Thursday, April 9, 2020** being the advert closing date shall be invited to submit Technical Bids.

Tenderers that are registered under NJQS Product category 3.08.01 but are not registered under 3.08.04 can submit their tender for Category 3: Field installation Vessels (FIV) and Diving Support Vessels (DSV), but will not be eligible to submit their Tenders for Category 1: Jack-up Vessels (JUV) or Category 2: Main Installation Vessels (MIV).

Please note that this advert replaces the previous advert published on Monday, January 27, 2020 for this same tender.

- (A) Interested suppliers must be prequalified for this product/service category in NJQS.
