#### **(1.0) INTRODUCTION**

SNEPCo hereby announces to interested and prequalified companies an upcoming tendering opportunity for the PROVISION OF OFFSHORE CONTAINER BASKETS (CCU) for movement of goods, materials and chemicals from Offshore Supply Bases (Onne/Lagos) to BONGA FPSO and Drilling Rigs Locations and associated facilities. The proposed contract is estimated to tentatively commence in Q1 of 2021 and remain active for a period of two (2) years, followed by one (1) year option.

#### **(2.0) OVERVIEW/SCOPE OF WORK**

The scope of work includes but not necessarily limited to:

- Provision and supply of CCUs meeting BS EN 12079/DNV2.7-1 standards to transport general onshore materials, chemicals, tools, waste, rubbish, stores, and food to SHELLS offshore field locations and assets.
- Provision and mobilization of all resources including labour, equipment, and land transportation necessary to provide the services in accordance with the CONTRACT.
- Provide certification and colour coding of the units in accordance with above standards and regulatory requirements.

#### **(3.0) MANDATORY REQUIREMENTS**

(1) To be eligible for this tender exercise, interested contractors are required to be pre-qualified as essential service vendors in the NJQS Product/Service category Reference: 3.08.05 Rental – Containers, Baskets – Chemical Tank, Hire in NipeX Joint Qualification System (NJQS) data base. Only successfully pre-qualified suppliers in this category will receive Invitation to Technical Tender (ITT).

(2) To determine if you are pre-qualified and view product/service category you are listed for, open [www.nipex-ng.com](http://www.nipex-ng.com) and access NJQS with your login details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.

(3) If you are not listed in a product/service category you are registered with DPR to do business contact NipeX office at 8, Bayo Kuku Street, Ikoyi, Lagos with your DPR certificate as evidence for necessary update.

(4) To Initiate the JQS prequalification process, access [www.nipex-ng.com](http://www.nipex-ng.com) to download the application form, make necessary payments and contact NipeX office for further action.

(5) To be eligible, all tenders must comply with the Nigerian Content Requirements in the NipeX system.

#### **(4.0) NIGERIAN CONTENT REQUIREMENTS**

Vendors are to demonstrate strict compliance with the provisions of Nigerian Oil & Gas Industry Content Development (NOGICD) Act and also provide the following requirements:

- Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria.
- International or multinational company working through a Nigerian subsidiary must demonstrate that a minimum of 50% of equipment to be deployed for execution of work shall be owned by the Nigerian subsidiary by providing a list of equipment for this tender and indicating those that will be owned by the Nigerian subsidiary.
- Furnish details of company ownership and shareholding structure. Also, submit clear photocopies of your CAC Forms C02 and C07.
- Provide evidence of what percentage of your key management positions is held by Nigerians and what percentage of the total work force are Nigerians. Also, show overall percentage of work to be performed in Nigeria and those by Nigerian resources relative to total work volume.
- Provide a Nigerian Content execution Plan providing a detailed description of the role work scope, man-hours and responsibilities of all Nigerian companies and personnel that would be involved in executing the work. Also provide details of Nigerian Content focal point or manager.
- State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses

including evidences of well-equipped offices and workshop, attach experience of such patronage.

- In line with the NCD Human Capacity Development Initiative, Bidder shall commit to providing Protect-Specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel utilizing OGTAN registered trainer(s) or other approved NCDMB training institution(s).
- Location of in-country facilities (Storage, workshops, repair & maintenance facilities and testing facilities).
- Contractor must be willing and able to provide evidence of maximization of mode in Nigeria goods and services
- Provide details on any other Nigerian Content initiative your company is involved in.

#### **(5.0) CLOSING DATE:**

Only Tenderers who are registered in the NJQS product/category 3.08.05 Rental – Containers Baskets-Chemical Tank, Hire as at **2 October, 2020**. Being the advert close date shall be invited to submit Technical bids.
