### **INTRODUCTION**

Star Deep Water Petroleum Limited (Company) invites interested and prequalified companies to this tender opportunity for the supply of Oil Country Tubular Goods (OCTG) & Services to support Company's Deep-Water Drilling and Completion Operations.

The proposed contract term is 2 (Two) years with an option of 1 (One) year extension.

### **SCOPE OF WORK:**

Anticipated Commencement Date: First (1st) Quarter 2019

The scope of work for the service includes but not limited to the following:

- (i) Manufacture and delivery of Casing, Tubing, Pups, Crossovers and related equipment.
- (ii) Associated services with each OCTG String to include: Cutting, Welding and threading of Pipes, Crossovers, Pups for Repairs, Buckling and Make-up of Shoe Joints.
- (iii) Capacity to carry out threaded inspection services in Star Deep Logistics Base or the Rig.
- (iv) Provision of support services towards making up of assemblies at the shore base and running of casing or production tubing during completions and workover operations.
- (v) Supply of well qualified and suitably experienced field engineers to supervise the tubing make up and running during Drilling, Completions and Workover operations.

(vi) Handling and Storage Capability of procured goods.

(vii) Maintenance of a detailed inventory of company equipment stored within contractor's base.

(viii) Bidder's shall provide a detailed schedule plan from manufacture to delivery at Contractor's base.

(ix) Contractor will supply Quality Plan outlining procedures to ensure that Company receives equipment that has been properly prepared for utilization. Dedicated QA personnel will be supplied by contractor to ensure rigorous adherence to Contractor's Quality Plan. Quality Plan will define shop equipment required to makeup and test equipment prior to shipment offshore

(A) To be eligible for this tender exercise, interested contractors are required to be pre – qualified in the 1.01.04 (Casing, Tubing, Liner, Connectors and Accessories (OCTG)) category in the NipeX Joint Qualification System (NJQS) database. All successfully pre- qualified suppliers in this category by the bid close date will receive Invitation to Technical Tender (ITT).

(E) To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

#### **NIGERIAN CONTENT REQUIREMENTS:**

Star Deep Water Petroleum Limited is committed to the development of the Nigerian Oil and Gas business in observance with the Nigerian Oil and Gas Industry Content Development Act 2010 (NOGICD Act) enacted by the Federal Government of Nigeria in April 2010.

Pursuant to enactment of the NOGICD Act, the minimum Nigerian Content in any project, service or product specification to be executed in the Nigerian Oil and Gas Industry shall be

consistent with the level set in the schedule of the Act and any other target as may be directed by the Nigerian Content Development and Monitoring Board (NCDMB).

Contractors shall comply with the provisions of the NOGICD Act and all applicable regulations. Bidders that do not meet the Nigerian Content criterion will not be allowed to participate in next Tender Stage.

The following are the Nigerian Content requirements bidders are expected to comply with in their technical bid submission.

- (B) Provide a description of its committed infrastructure (asset, equipment, technical office, and administrative space, storage, workshop, assembly area, repair, and maintenance, testing, etc.) in Nigeria (offices, equipment etc.) to support this contract.
- (C) Demonstrate key Management positions that are Nigerian Nationals and the percentage of the Company total workforce (direct and in-direct employees) that are Nigerians with CVs.
- (D) Provide evidence of owning in-country threading facility or MOA with in-country owner of such facility.
- (E) Provide evidence of 50% Nigerian ownership of all equipment to be deployed for this project.
- (F) Tenderer shall demonstrate in accordance with the NOGICD Act 2010, a minimum of 95% in-country Man-hour as specified in the Schedule A for this service.
- (G) Provide description of how bidder would maximize the utilization of Nigerian resources (materials, goods and services) in the execution of this contract. Submit the list of goods, raw materials and equipment of Nigerian origin to be procured.
- (H) Provide a description of Project-specific training, man-hour, budget, skill development and understudy plan for Nigerian personnel in key areas. In line with NCD Human

Capacity Development Initiative, Tenderer to provide details on contract-specific training man-hours for Nationals to feed the National skill pool.

Only tenderers who are pre-qualified and Live with NJQS Product/Category 1.01.04 (Casing, Tubing, Liner, Connectors and Accessories (OCTG)) by **4:00 pm., on 17, August, 2018**, being the advert close date shall be invited to submit Technical Bids.

- (2) The Invitation to Tender (ITT) and any further progression of this tender shall be via NipeX.
