(1) INTRODUCTION:

ADDAX PETROLEUM DEVELOPMENT (NIGERIA) LIMITED (hereinafter referred to as “APD(N)L”) in association with ADDAX PETROLEUM EXPLORATION (NIGERIA) LIMITED invites interested and pre-qualified Contractors to respond to this tender opportunity for the provision of the following services as detailed in item 2 below, at APD(N)L OML-123, OML-126 and OML-137 facilities. The contracts are proposed to commence in Q2, 2019 and continue for a duration of two (2) years with APD(N)L having the sole option to extend the duration for a further period of one (1) year.

(2.0) SCOPE OF SERVICES REQUIREMENTS:

Initial requirements are the provision of Diving Services. This work shall be performed on APDNL offshore concessions in Nigeria on 24 hours, 7 days/week basis.

Contractor scope of work comprises

RIG POSITIONING

- Provision of all necessary equipment to facilitate accurate positioning of the rig
- DGPS receivers for differential correction
- Gyroscopic compasses
- Appropriate computers and monitors for rig
- Provision of equipment comprising appropriate computers, monitors and gyroscopes on the anchor handling vessels to enable accurate location of known sea bed obstructions ie, wellheads, flowlines etc,
- Rigging up and rigging down of all provided equipment
- Provision of qualified and competent personnel to operate equipment and coordinate anchor handling vessel management and radio communication.
- Provision of plotting equipment to make hard copy records of operations.
- Provision of full and complete report of each rig move operation.
- Provision of full and complete report of each final position.

DIVING SERVICES

- Seabed survey, locate and mark any obstruction or large accumulation of debris on the seabed in the area specified by COMPANY.
- Locate pipelines in the specified area and mark them with marker buoys.
- Anode inspection under platforms.
- Riser clamp inspections.
- Checking and removal of marine growth on platforms.
- Maintenance of fendering on platform boat landing stages.
- Removal of debris such as fishing nets from platform structures.

(3.0) MANDATORY REQUIREMENTS:

(3.1) To be eligible for this tender exercise, interested contractors are required to be pre-qualified in the 3.01.06 Subsea/Diving/ROV Technology Services and 3.09.01 Navigation/Positioning Services (Product/Services) category in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in these categories will receive Invitation to Tender (ITT).

(3.2) To determine if you are pre-qualified and to view the product/service category you are listed for, open <http://vendors.nipexjqs.com> and access NJQS with your log in details. Click on Products/Services Status tab to view your status and product codes.

(3.3) If you are not listed in a product/service category that you are registered with DPR to do business, you may contact NipeX Office at 8/10 Bayo Kuku, Ikoyi, Lagos, with your DPR certificate as evidence for verification and necessary update.

(3.4) To initiate the NJQS pre-qualification process, access www.nipex-ng.com click on services tab followed by NJQS registration.

(3.5) In addition to 3.1 above, Tenderers shall also be required to comply with the Nigerian Content requirements in the NipeX system.

(4.0) NIGERIAN CONTENT REQUIREMENTS:

Tenderers are to note that they will be requested during the technical tender to provide details of their relevant strategy to ensure that they fully comply with the Nigerian Oil & Gas Industry Content Act, 2010 as provided at <http://www.ncdmb.gov.ng/images/GUIDELINES/NCACT.pdf> in view of the fact that non-compliance will constitute a fatal flaw in all contract evaluations.

In light of the above, Tenderers shall be expected by the Nigerian Content Development Monitoring Board (NCDMB) to:

(a) Demonstrate that the entity proposed for execution of the service, is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work.

Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies including evidence or plans of physical operational presence and set-up in Nigeria

(b) Furnish details of company ownership and share holding structure. With photocopies of its CAC Forms CO2 and CO7

(c) Provide evidence of what percentage of its key management positions are held by Nigerians and what percentage of the total work force are Nigerians. And also show overall percentage of work to be performed by Nigerian resources relative to total work volume.

(d) Provide a Nigerian Content Plan with detailed description of the role, work scope, man-hours and responsibilities of all the Nigerian companies and personnel that will be involved in executing the work.

(e) State proposed total scope of work to be conducted by Nigerian personnel (whether contracted directly or under subcontract agreements) with names and addresses including evidences of well-equipped offices and workshop.

(f) Provide detailed plan for staff training and development on engineering, project management and procurement (including all software to be used, number of personnel, name of organization providing such training and evidence of past training record) for Nigerian personnel including description of any specific programs in place for transfer of technology and skills to indigenous businesses and Nigerians over the next five (5) years.

(g) Provide evidence of domiciliation of project management and procurement centers in Nigeria with physical addresses (not P.O. Box).

(h) Provide detailed description of the location of in-country facilities (Equipment, storage, workshops, repair, maintenance and testing facilities)

(i) Provide detailed statement with evidence of how it intends to maximize the use of Nigerian made goods and services.

(j) Provide details on any other Nigerian Content initiative the company is involved in.

(k) Provide evidence of Nigerian Content Equipment Certificate (NCEC).

(l) Provide MOA with Oil & Gas trainers association (OGTAN) registered facility for both class room type (theoretical) and on-the-job training attachment for the duration of the project.

(m) Provide evidence of minimum 50% equity ownership of equipment by Nigerian subsidiary

(5) CLOSING DATE

Only Tenderers who are registered with NJQS under the applicable Product/category 3.01.06 Subsea/Diving/ROV Technology Services and 3.09.01 Navigation/Positioning Services as at **1200 Hours on 18 of September, 2018** being the advert closing date shall be invited to submit Technical Bids and Commercial Bids.

(6) GENERAL CONDITIONS

Please note that all interested Contractors are required to strictly adhere to following conditions in relation to their response to this Advert:

(a) As stated in item 3 hereto, Contractors are required to be pre-qualified in NJQS under this specific Services category to be eligible to participate in this tender opportunity.

(b) To enable interested pre-qualified Contractors to use the NipeX System to progress this tender exercise, they should access the NipeX System and include within their company profile, a name of a principal personnel, his/her phone number and the Contractor's general official email address for NipeX System set-up and training purposes.

(c) All costs incurred in preparing and processing NJQS pre-qualification and responding to this Tender Opportunity shall be to the Contractor's own account.

(ii) Following the Technical evaluation process, only Commercial Tenders from the technically acceptable and financially qualified contractors will be opened for evaluation.
