- (3) Details of Company ownership and shareholding structure with certified true copies of CAC forms C02 and C07, including company memorandum & article of association and other evidence of entity's incorporation.
- (4) Supplier's sourcing strategy/plan for this scope of service; and evidence of source of products, materials etc.
- (5) Current and in-place organization structure with detailed experience and skills of key management personnel with names.
- (6) Evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian nationals and the percentage of the total workforce that are Nigerians.
- (7) Detailed training plan for the service.
- (8) Detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, storage facilities etc) in Nigeria to support this contract or submit a credible and verifiable plan towards setting-up.
- (9) Details of the applicant's relationship with local suppliers and service providers (e.g. in the management of the logistic, personnel).
