(1) Introduction

Nigerian Agip Oil Company Limited (NAOC) intends to put in place open contracts for the emergency leak repair of pipelines and flow-lines in NAOC Swamp area for a firm period of 2 years and a 1 year optional extension. The Swamp Area is located within the Niger Delta Region (OML 62&63) and it is a marshy area only accessible by water

NAOC therefore uses this medium to inform suitable and reputable Companies having requisite experience and resources for the execution of project of this magnitude to register or update their registration with NipeX for consideration in the subject opportunity.

(2) Scope of Service

**Activities requested:** 

- (a) Execute the work in compliance with NAOC HSE and Construction Procedures
- (b) Carry out detailed joint verification with authorities to ascertain the actual cause of failure or leak prior to repair activities
- (c) Carry out cleaning of the affected area of operation to safeguard repair operations;
- Containment of spilled crude around affected point on the facility.
- Transfer of recovered spilled crude oil to approved Company facility
  - (d) Clearing, cleaning and foaming of affected area around the point to be repaired with fire retardant chemical foam to create a safe work zone for repair activities
  - (e) Excavation to expose affected section of the facility
  - (f) Carry out Gas testing to ascertain conducive gas level to commence activities and throughout the repair activity duration
  - (g) Carry out repairs (coning, patch welding, full encirclement and sectional replacement where necessary) of the damage or defective area of the pipeline
  - (h) Carry out NDT (UT test and or Dye Penetrant Inspection) of all welded joint in accordance with standard

- (i) Priming and wrapping with polyken tape/shrinkable sleeves/concrete (as may be applicable)
- (j) Backfilling
- (k) Site restoration
- (l) Mobilization/Demobilization (as may be applicable)

## (3) Mandatory Requirements

- (a) To be eligible for this tender exercise, interested Contractors are required to be pre-qualified in the 3.05.01 Steel/Piping/Mechanical Services) category A-D in NipeX Joint Qualification System (NJQS) database. All successfully pre-qualified suppliers in this categories will receive Invitation to Technical Tender (ITT).

- (e) To be eligible, all lenders must comply with the Nigerian Content requirements in the NipeX system.

# (4) Nigerian Content

Bidders are invited to express complete understanding and willingness to comply with the Nigerian Oil and Gas Industry Content Development (NOGICD) Act 2010. Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act provisions/Schedule. Only bidders whose submissions are in compliance shall proceed to the next stage of the tendering process.

The following are some of the information/documentation that will be required for submission at the ITT stage:

(a) Demonstrate that the entity is a Nigerian Registered Company, or Nigerian Registered Company as the contracting entity in genuine alliance or joint venture with foreign company with details on scope and responsibilities of parties for this work. Such companies must show evidence of joint venture Memorandum of Agreement signed by chief executives of the entities that evidences clear work-share

ratio among the parties including evidence or plans of physical operational presence and set-up in Nigeria;

- (b) Proposed indigenous Company -should be the lead contractor and the MOA should be governed by the laws of the Federal Republic of Nigeria to execute scope of work.
- (c) Details of Company ownership and shareholding structure with certified true

copies of CAC forms C02 and C07, including company memorandum & article of association and other evidence of entity's incorporation;

- (d) Provide detailed description (address and layout drawings) of where procurement center and warehouse in Nigeria will be
- (e) Nigerian Content Plan with detailed description of the role, work scope, man

hours and responsibilities of all Nigerian companies and personnel that are involved in executing the service; that addresses utilization of Nigerian labour, services, materials and equipment for this service, aimed at achieving the minimum Nigerian Content requirements for this category in line with targets set in the schedule to the NOGICD ACT 2010;

- (f) Current and in-place organization structure with detailed experience and skills of key management personnel with names;
- (g) Evidence (personnel list and positions with organization chart to substantiate) of percentage of management that are Nigerian nationals and the percentage of the total workforce that are Nigerians;
- (h) Detailed training plan for the service;
- (i) Detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, storage facilities etc) in Nigeria to support this contract or submit a credible and verifiable plan towards setting-up;
- (j) Details of the applicant's relationship with local suppliers and service providers (e.g.in the management of the logistic, personnel);
- (k) Evidence of Nigerian Content Equipment Certificate (NCEC) or evidence of application to NCDMB for the issuance of the Nigerian Content Equipment Certificate;

(l) State any further innovative proposals that would enhance the development of Nigerian Content for the Project

- Bidders shall be requested to provide evidence to show their compliance with the above listed requirements at the ITT stage.
- Failure to meet the Nigerian Content requirements is a "FATAL FLAW."
