**Tender Opportunity: Provision of Inspection, Analysis and Diagnostics of Hydrocarbon Transport/Process Facilities for NAOC**

**(1) INTRODUCTION**

**Nigerian Agip Oil Company Limited (NAOC)** intends to put in place an open contract for the Provision of Inspection, Analysis and Diagnostics of Hydrocarbon Transport/Process Facilities for NAOC.

Contractor shall take coverage of all costs and expenses for all services provided hereunder for the duration of the contract.

The proposed open contract shall cover a period of two(2) years plus one (1) year optional extension.

NAOC through this Tender announces to interested reputable Nigerian Companies and NJQS prequalified Companies in line with Clause 3 (2) of the NOGICD Act 2010' of the defined scope of services as hereunder outlined:

**(2) SCOPE OF WORK**

**This shall include but not limited to the following:**

Provision of services for the inspection, evaluation and diagnosis of all NAOC flow lines, pipelines and process lines.

Contractor shall perform inspection of the aforementioned facilities in order to assess their integrity, diagnose their current status and estimate their remaining life to guarantee a secured operation and to ensure that Company's Key Performance Indicator (KPI) are met i.e. within allowable minimal thickness of 5.56mm.

For each particular station, Company shall indicate which facilities (flowlines, pipelines, pipelines and process lines) are to be inspected and what specific services will be required in accordance with this scope of work.

Contractor shall provide all materials, personnel, equipment / tools / instruments and logistics required to perform services in accordance with Company's specifications and international standards.

**(3) Mandatory Requirements**

- (a) To be eligible for this tender exercise, interested Contractors are required to be pre-qualified under product code **40404 – Pipeline Systems, Categories A, B, C & Din** NipeX Joint Qualification System (NJQS) database. **All successfully pre-qualified suppliers in this categories will receive Invitation to Technical Tender (ITT).**
- (b) To confirm if you are pre-qualified and view the product/service category you are listed for: Open [www.nipexng.com](http://www.nipexng.com) and access NJQS with your log in details, click on continue Joint Qualification Scheme tool, click check my supplier status and then click supplier product group.
- (c) If you are not listed in a product/service category but you are registered with DPR to do business, contact NipeX office at **30, Oyinkan Abayomi Street, Ikoyi Lagos with your DPR** certificate as evidence for verification and necessary update.
- (d) To initiate the NJQS pre-qualification process, access [www.nipexng.com](http://www.nipexng.com) to download application form, make necessary payments and contact NipeX office for further action.
- (e) To be eligible, all tenders must comply with the Nigerian Content requirements in the NipeX system.

#### **(4) NIGERIAN CONTENT**

Bidders are invited to express complete understanding and willingness to develop in-country capability and capacity for related work packages in compliance with the Nigerian Oil and Gas Industry Content Development Act (NOGICD, 2010) and other extant laws.

Pursuant to the above, bidders' submissions shall be evaluated strictly with the minimum evaluation criteria defined in the NOGICD Act, only bidders' whose submissions are in compliance shall proceed to the next stage of the tender process.

**The information/documentation that will be required to be submitted by bidders at the ITT stage among others are as follows:**

- (1) Nigerian Content Plan that addresses utilization of Nigerian Labour, Services-, Materials and Equipment for this service in order to achieve the minimum targets as set out in line with the requirements of the NOGICD ACT.
- (2) Provision of evidence that 50% of the equipment deployed is owned by the Nigerian subsidiary if applying entity is a multinational (Clause 41 (2) of the NOGICD Act). If not the case provision of concrete plan to comply in the next 3 years.
- (3) Provision of detailed description of the role, work scope, man-hours and responsibilities bidders will accomplish using Nigerian Resources (Labour, Material & Services)

- (4) Detail past experience/present commitment to staff training and development of its Nigerian personnel. Furnish details of specific training plans that will be provided for Nigerians specific to this scope of work'
- (5) Demonstration that entity is a Nigerian company as defined in Clause 3(2) of the Act which gives Exclusive consideration to Nigerian Indigenous service companies which demonstrate ownership of equipment, Nigerian personnel and capacity to execute such work to bid on land and swamp area of the Nigerian oil and gas industry
- (6) A Nigerian Registered Company as the contracting entity and lead contractor in executing scope of work can form genuine alliance or joint venture partnership with foreign company showing details of scope and responsibilities of parties for this work.
- (7) Such companies must show evidence of joint venture binding agreement duly signed by the CEO of both companies which must be governed by the laws of the Federal Republic of Nigeria including evidence or plans of physical operational presence and set-up in Nigeria
- (8) Provision of company ownership details, shareholding structure and copies of CAC forms C02 and C07, including company memorandum & article of association.
- (9) Innovative proposals that would enhance the Nigerian Content for the project and other associated activities in-country.
- (10) Detailed training plan for the service;
- (11) Detailed description of the location of in-country committed facilities & infrastructure (assets, equipment, storage facilities etc) in Nigeria to support this contract or submit a credible and verifiable plan towards setting-up;
- (12) Details of the applicant's relationship with local suppliers and service providers (e.g. in the management of the logistic, personnel)
- (13) Evidence of equipment Ownership to execute scope of work
- (14) Bidder/Contractor/Service company or Subcontractor/Third party provider shall submit as part of Nigerian Content requirement, a signed MOA between it and one of the R&D Clusters relevant to the project. The MOA shall indicate how the Service company intends to use the relevant research Clusters during project execution to the satisfaction of the Board. The MOA shall form part of the documents to be reviewed at technical evaluation stage.

**NOTE:** Failure to meet the Nigerian Content requirements is a “FATAL FLAW.” **NOTE:**  
**Only Nigerian Companies are qualified for this service.**

Bidders shall be requested to provide evidence to show their compliance with the above listed requirements at the ITT stage.

**(5) CLOSING DATE**

Only tenderers who are registered with the relevant NJQS product/service code 4.04.04 – Pipeline Systems, Categories A,B,C & D as **at 7th November 2016**, being the advert closing date, shall be invited to submit Technical Bids.
