**(2) SCOPE OF PROJECTS**

The project to be executed and to which Technical/ Financial bid documents of contractors are invited, is:

**(3) TECHNICAL BID:**

The Technical/Tender documents should include: –

- (a) Evidence of compliance Certificate of Incorporation with Corporate Affairs Commission (CAC).
- (b) Company's current/Valid Tax Clearance Certificate for the last three (3) years.
- (c) Current Pension Compliance Certificate from PENCOM.
- (d) Evidence of Compliance with Industrial Training Fund (ITF) Act No. 19 of 2011.
- (e) Evidence of Compliance with the National Social Insurance Trust Fund (NSITF)

- (f) Evidence of Registration on the National Database of Contractors, Consultants and service Providers by BPP or a copy of interim Registration Report (IRR) as evidence of compliance with the requirement.
- (g) Company current audited account for the last three (3) years.
- (h) VAT registration and evidence of remittance in the last three (3) years.
- (i) Evidence of Financial Capability to execute the project. Bank reference and a letter of credit facility from a reputable Commercial Bank with a commitment to provide loan facility for the execution of the contract if eventually won.
- (j) List of similar, verifiable and successfully executed projects or ongoing by the Company with letters of award and completion certificates, in the last three years, 2015 2017 only. Letters of award and interim certificates of payment should be attached for projects that are ongoing.
- (k) List of key personnel and evidence of proficiency and experience.
- (l) List of Equipment owned or on lease hold by the company relevant for smooth execution or the project.
- (m) A sworn affidavit indicating that all documents submitted are genuine, verifiable and that no officer of Umaru Musa Yar'adua University, Katsina is a former, present director or shareholder and has no interest in the company.
- (n) A sworn affidavit that none of the directors have been convicted in any country for any criminal offence including fraud or financial impropriety.

#### **(4) COLLECTION OF BID DOCUMENTS**
