(g) Evidence of current Nigeria Social Insurance Trust Fund (N.S.I.T.F) Compliance Certificate valid till 31st December, 2018.

(h) Evidence of financial capability to execute the project including Bank Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.

(i) Company's Audited Account for the last 3-years (2015, 2016 & 2017) duly stamped by licenced auditor.

(j) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: CORCN, QSRBN, ARCON CORSON etc.);

(k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

(I) List of Plants/Equipment with proof of ownership/Lease (where applicable);

(m) Sworn Affidavit disclosing whether or not any officer of the Citizenship and Leadership Training Centre or Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the company and to confirm that all information presented in its bid are true and correct in all particulars;

(n) For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (all the eligibility requirements are compulsory for each JV partner)

(o) Companies bidding for the procurement of vehicle must be included in the National Automotive Design and Development Council's approved list of local manufacturers of vehicles or their authorised representatives should bid for the procurement;
