NNAMDI AZIKIWE UNIVERSITY CORRIGENDUM

P.M.B. 5025, AWKA

With reference to our advertisements on the Federal Tenders Journal of Monday 19th February 2018. The Daily Sun and the Vanguard Newspaper's of Wednesday, 21st February 2018 respectively, the University wishes to request prospective bidders to note the following amendments / additions:

(A) ELIGIBILITY CRITERIA

- (i) Evidence of current Tax Clearance Certificate for the past 3 years (2014, 2015 and 2016);
 - (ii) Evidence of current Pension Compliance Certificate (2017);
 - (iii) Evidence of current Industrial Training Fund (ITF) Compliance Certificate (2017);
 - (iv) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate (2017);
 - (v) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including Letters of Award, Valuation Certificates and Job Completion Certificates;
 - (vi) Evidence of financial capability to execute the project including Bank Statement and Reference Letter from reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
 - (vii) Evidence of Registration on the National Database of Federal Contactors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 30/6/2018 or valid Certificate issued by BPP.
- (b) Sworn Affidavit to certify that all information provided are true, that the company is not in receivership, insolvent or bankrupt and no officer of the University or the Bureau of Public Procurement is a former or present director, shareholder or has any pecuniary interest in the company.
- (c) The tender fee has been reduced and pegged at N10,000.00 per lot and this should be paid into the University's Treasury Single Account (TSA)

(d) Note that only technical bids will be opened on the bid opening date at the deadline for submission **on Thursday 5th April 2018** while the financial bids of bidders successful in the technical evaluation will be opened at a later date and the financial bids of the unsuccessful bidders will be returned to them un-opened;

(e) Please note that only contractors who have executed and timely completed similar projects of single value above N120.0million for items (a to d); and N80.0million for item (e) within the last (5) Five years may apply.

(f) Note that no bidder should bid for more than two (2) Lots.

(g) Contractors who failed to deliver their projects within the completion deadline should not apply.

Nnamdi Azikiwe University hereby invites reputable, qualified and competent firms for Prequalification and tender for the following projects:

(a) Construction of 500 seating capacity Examination /Lecture Hall;

(b) Rehabilitation / resurfacing of the Access Road from the Banking Plaza to the Law Faculty Junction;

(c) Completion of the Access Road from the Banking Plaza Junction to after the Guaranty Trust Bank including Parking Lots for the Multi Purpose Hall for Education;

(d) Construction of the Extension to the School of Post Graduate Studies Building;

- (e) Construction of Gate House for the Beautiful Gate.

TENDER REQUIREMENTS

Qualified and interested bidders are required to submit the following documents/ evidence for the Pre-qualification and tender:

- (a) Evidence of payment of non-refundable deposit of N20,000.00 (Twenty Thousand Naira only) for each of the items 'a' to 'd', and N15,000.00 (Fifteen Thousand Naira only) for item 'e'.
- (b) Certificate of registration/incorporation with the Corporate Affairs Commission.
- (c) Current TAX Clearance Certificate (TCC) for the past 3ycars.
- (d) Evidence of current Certificate of Compliance with the National Pension Commission;
- (e) Evidence of current ITF Compliance Certificate; and as well as NSITF
- (f) Evidence of Registration on the National Database of contractors, consultants and service providers by inclusion of Interim Registration Report (IRR).
- (g) Details of verifiable experience of completed similar projects/evidence of timely completion of projects of similar nature and magnitude executed by the firm within the last (3) three years.
- (h) Financial Status of the Company: Evidence of financial capability and evidence of own funds of the company.
- (i) Details of plants and equipment owned by the company and verifiable addresses of their locations
- (j) Resume of key professional and other staff to be involved in the work and evidence of registration with the relevant professional bodies.

Bidders are hereby informed that all Bids received shall be publicly opened in the Council Chamber of the University by **12:00noon on Tuesday, 3rd April, 2018** immediately after the close of submission of bids.

- (ii) Contractors who have on-going projects in the University and contractors who delayed / prolonged the completion of their projects need not apply.
