 - (v) Company profile with curriculum vitae (C.V.) of professional staff to be deployed for the project including copies of their professional qualification;
- (b) (i) A sworn affidavit disclosing whether or not any officer of the relevant committee of Benue State Polytechnic or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (ii) Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of interim registration report (IRR) expiring on 30/8/2018 valid certificate issued by BPP
 - (iii) List of plants/equipment with proof of ownership/lease; (where applicable) and readiness to deploy them to site within short time;
 - (iv) The minimum turnovers for the projects (where applicable); which should be in line with the formula specified in the Standard Bidding Document (SBD) for works published by the Bureau of Public Procurement.

- (i) Evidence of tax clearance certificate supersedes evidence of remittance and value added (VAT)
- (ii) A bidder should not bid for more than two lots (2 lots)
