(1) INTRODUCTION

The University of Ilorin Teaching Hospital, Ilorin, hereby invites reputable and competent Companies/Firms with relevant experience and good track records to submit Expression of Interest for Consultancy Services for 2021 Capital Projects.

(2.0) SCOPE OF SERVICE

The works include architectural, structural, quantity surveying, electrical and mechanical consultancy services for the following Projects:

Lot 1	Construction and furnishing of schools complex (students' Blocks of Hostels, classrooms, Auditorium &
Lot 2	Construction and Equipping of VIP Wards Phase 2
Lot 3	Installation of Dedicated power line from Ganmo sub-station to Hospital location
Lot 4	Construction of Lecture Halls and Auditorium for Schools of Nursing, Midwifery, Health Records etc

Lot 5	Construction of Comprehensive Health Centre at Federal Low Cost Housing Estate Oloje, Kwara Centre furnishings)
Lot 6	Mobile Health Clinics for Kwara Central Senatorial District
Lot 7	Rehabilitation of Internal Road Network with Asphalt Laying and Landscaping
Lot 8	Construction and Equipping of New Oxygen Plant.

ELIGIBILITY REQUIREMENTS

Interested Consortium/Joint Venture should submit 2 (Two) bound Expression Of Interest (EOI) documents duly signed, paginated, separated by dividers and arranged in the order outlined hereunder:

- (a) Evidence of Certificate of Incorporation issued by Corporate Affairs Commission (CAC) including Form CAC 1.1 or CAC2 and CAC7. Business Name is also acceptable;
- (b) Evidence of Company's Income Tax Clearance Certificate (or Personal Income Tax Clearance Certificate of all the Partners in case of Business Name) for the last three (3) years valid till 31 December, 2021;
- (c) Evidence of current Pension Clearance Certificate valid till 31st December, 2021;
- (d) Evidence of Current Industrial Trust Fund (ITF) Compliance Certificate valid till 31st December, 2021;
- (e) Evidence of Current Nigeria Social Insurance Trust Fund (NSITF) Clearance Certificate valid till 31 December, 2021;
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31 December, 2021 or valid Certificate issued by BPP;
- (g) Evidence of Firm's current Practice License issued by relevant professional body(ies) e.g. COREN, QSRBN, ARCON, CORBON, NEMSA etc;

- (h) Sworn Affidavit disclosing whether or not any officer of the relevant Committees of the University of Ilorin Teaching Hospital or the Bureau of Public Procurement is a former or present Director, Shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (i) Company's Audited Accounts for the last 3 (three) years (i.e. 2018,2019 & 2020);
- (j) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable Commercial Bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- (k) Company's Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their academic/professional qualifications (e.g. COREN, QSRBN, ARCON, CORBON etc.);
- (I) Verifiable documentary evidence of at least three (3) similar jobs executed in the last 5 (five) years (i.e from 2015 to date), including Letters of Commissioning, Drawings and Photographs of the projects;
- (m) For Joint Venture/Partnership, Memorandum of Understanding(MoU) should be provided (CAC, Tax Clearance Certificate, Pension Clearance Certificate, ITF Compliance Certificate, NSITF Clearance Certificate, IRR & Sworn Affidavit are compulsory for each JV partner);
- (n) All documents for submission must be transmitted with a Covering/Forwarding letter, indicating the Lot interest being expressed under the Company/Firm's Letter Head, bearing amongst others; the Registration Number (RC) as issued by Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM number), and an email address. The Letterhead must bear the Names and Nationalities of the Directors of the company at the bottom of the page, duly signed by an authorized officer of the firm.

(4.0) SUBMISSION OF EOI

Interested Firms are to submit two (2) bound of Expression of Interest (EOI) Documents, separated by dividers and arranged as indicated above clearly indicating the Lot they are submitting for. (6.0) GENERAL INFORMATION

- (a) EOI must be in English Language and signed by an official authorised by the Firm;
- (b) EOI submitted after the deadline for submission would be returned un-opened;
- (c) All costs will be borne by the Firms;
- (d) Presence of bidders/representatives and members of the public shall not be required during the bid opening ceremony in compliance with COVID-19 Guidelines. The Bids Opening will be covered by video recording with the presence of two (2) representatives of private sector professional bodies and Civil Society Organization in the areas of Anti-Corruption/Transparency;
- (e) Bidders can submit through Post (Courier Service);
- (f) Only shortlisted Firms will be contacted at a later date for collection of Request for Proposals;
- (g) The University of Ilorin Teaching Hospital is not bound to shortlist any bidder and reserves the right to annul the Procurement Process at any time without incurring liabilities in accordance with Section 28 of Public Procurement Act 2007.
