(2.0) INFORMATION REQUIRED FOR EXPRESSIONS OF INTEREST (EOI)

All interested firms are to submit copies of the following;

- (i) Evidenced of registration with the Corporate Affairs Commission (CAC) as a Limited Liability Company.
- (ii) Evidence of current Tax Clearance Certificate valid till 31st December 2018.
- (iii) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December 2018.
- (iv) Evidence of current Pension Compliance Certificate valid till 31st December 2018.
- (v) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December 2018.
- (vi) Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31st of December, 2018 or valid Certificate issued by the Bureau for Public Procurement (BPP).
- (vii) Copy of Certified Audited company Accounts for the immediate past three years (2015, 2016, and 2017) duly stamped by certified auditors.
- (viii) Copy of current Professional Certification and Registration of Firm with the relevant professional body.
- (ix) A sworn affidavit certifying that the documents submitted for the exercise are not only genuine but correct, none of the company Director(s) have been convicted by any law court for

any criminal offence relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter.

- (x) A sworn affidavit certifying that the company is not in any bankruptcy proceedings or in receivership or the subject of any form of insolvency or in any form of winding up petition proceedings, and none of the officers of the University of Abuja or Bureau for Public Procurement (BPP) is a former or present Director of the company.
- (xi) Evidence of commission for at least five (5) Consultancy services jobs in the last five (5) years.
- (xii) Any other information that will assist the evaluation of the service provider's suitability for the job

Opening of the Expression of Interest Documents shall take place at 12noon of Thursday, 23rd August, 2018 in the reception hall of the Senate Building, Main Campus, Airport Road, Abuja.
