**(3) Requirements:**

- (v) Registration with the Cross River State Due Process and Price Intelligence Bureau in the relevant category.

- (vi) Evidence of Financial capability/Bank Support.
- (vii) Firm's Audited Accounts for three years (2013-2015).
- (viii) Evidence of Tax clearance Certificate for the past three years (2013-2015).
- (ix) Technical qualifications and experiences of key personnel (Firm's profile including details of professional staff strength to be deployed to render the services)
- (x) Any other information that may enhance a firm's qualification as a Consultant.
