(3.0) ELIGIBILITY CRITERIA

- (i) Evidence of registration with Corporate Affairs Commission (CAC).
- (ii) Evidence of Tax payment by inclusion of 3 years/tax clearance Certificates 2014, 2015, and 2016.
- (iii) Evidence of PENCOM compliance certificate expiring by December 2017.
- (iv) Evidence of compliance with Industrial Training Fund (ITF) by inclusion of ITF certificate expiring by 2017.
- (v) Interim Registration Report (IRR) as evidence of registration on the National Database of Federal Contractors, consultant and Suppliers issued by the Bureau of Public Procurement.
- (vi) Evidence of registration with the FRCN.
- (vii) That the company does not have any director who has ever been convicted in any court in Nigeria or any other country for criminal offence in relation to fraud or financial Impropriety.

(viii) Whether or not any officer of the Federal Ministry of Education is former or Present Director, Shareholder or has a pecuniary Interest in the bidder.

(ix) Previous experience and verifiable list of similar project such as letter of awards and completion certificate in at least jobs of similar nature.

(x) Evidence of financial capability and support from a reputable bank.

(xi) Sworn Affidavit of disclosure that the company is not in receivership, insolvent or bankrupt and none of the Staff of (PSIN) or (BPP) has a pecuniary interest in the company; and

(xii) Company Audited account for the past three years (2014. 2015 and 2016) verifiable evidence of financial support from a reputable bank indicating their readiness to provide credit facilities.

(4.0) COLLECTION OF TENDER DOCUMENTS

Interested companies are to collect their tender documents from the Tender Secretariat in the office of the College Bursar, Federal Science and Technical College, Michika, Adamawa State as from Monday, 25th September, 2017 on the presentation of evidence of payment of non-refundable tender fees of Twenty Thousand Naira only (N20.000.000) per LOT through the College Remita Account No. 051702608300.

The envelop should be duly marked "Lot No/Technical and Financial" on the right hand comer. The bids should be dropped In the Tender Box at the office of the Principal, FSTC, Michika, Adamawa State, after signing the Bid submission register.

(6.0) BIDS CLOSING

All documents must be submitted on or before 12 noon of 30th October, 2017.

(7.0) OPENING

Opening of the received documents would commence immediately after closing time stated above at FSTC, Michika Conference Room. All contractors or their representatives, relevant professional bodies, CSO and NGOs are invited to witness the public opening exercise accordingly.

(8.0) PLEASE NOTE THAT:

(i) A post review of the Procurement document may be carried out where contractor may be required to present the original copies of the CAC, PENCOM, TAX, ITF Certificates and may thereafter refer any/all to relevant security agencies. Corporate Affairs Commission (CAC), Federal Inland Revenue Service (FIRS), National pension Commission and other relevant bodies for verification.

(ii) Contractors are not permitted to bid for more than one lot. Any bidder that violates this rule will be disqualified and the only successful bidders will be invited for the next stage of the bidding process.

(iii) The FSTC Michika, Adamawa State reserves the right to reject any or all the submissions that do not meet up with the requirements as specified.
