(2) ELIGIBILITY REQUIREMENTS

- (a) Evidence of Certificate of Incorporation with the Corporate Affairs Commission (CAC) including Form CAC2 and CAC7;
- (b) Evidence of Company Income's Tax Clearance Certificate for the last three (3) years valid till 31st December, 2018;
- (c) Evidence of current Pension Compliance Certificate valid till 31st December, 2018;
- (d) Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2018;
- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31st December, 2018;

(f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1/1/2018 or valid Certificate issued by BPP.

(g) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Federal Teaching Hospital Gombe, or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;

(h) Company's Audited Accounts for the last three (3) years – 2015, 2016, 2017;

(i) Evidence of financial capability to execute the project by submission of Reference Letter from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;

(j) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARGON, CORBON etc.);

(k) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Awards, Valuation Certificates, Job Completion Certificates and Photographs of the projects;

(l) List of Plants/Equipment with proof of Ownership/Lease (where applicable);

(m) For procurement of Medical Equipment, bidders must provide evidence of Manufacturer's authorization from the approved Manufacturers listed in the procurement policy of Medical Equipment

(n) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firms Letter Head Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the Names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(3) COLLECTION OF TENDER DOCUMENTS

Tender documents can be obtained from the Office of the Secretary Management Tenders Board (Administrative Block Upstairs) Federal Teaching Hospital, Gombe after payment of non-refundable tender fee of N10,000.00 per Lot into the Federal Teaching Hospital, Gombe's Remita account.

All Completed Technical and Financial Tender shall be submitted in Two (2) separate sealed envelopes, clearly marked 'Technical Tended for Lot... and Financial Bid for Lot.... (Indicate the Lot Number) which shall be inserted in a bigger third sealed envelope. The projects title, lot number and contractor's name must be clearly written on top of each envelope which must be dropped in the Tender Box located at the Administrative Building (Ground Floor) of the Hospital **not later than Monday, 17, September, 2018 at 10:00am.**

(5) BID OPENING

Only Technical bids will be opened at the deadline for submission **on Monday, 17, September, 2018 at 10:00am** in the Hospital Conference Hail (Hospital Complex, G.O.P.D upstairs). Contractors or their representatives are invited to attend the opening exercise. Financial bids for the successful bidders will be opened on subsequent date, while those for unsuccessful bidders will be returned unopened
