- Evidence of tax payments (current tax clearance certificate) for the last three years (2014,2015 and 2016).
- Evidence of Financial capability to execute the project (bank reference letter/bank guarantee will form part of the evaluation criteria).
- Evidence of Firm's corporate registration with relevant professional bodies.
- Corporate profile of firm(s) with curriculum vitae of key personal showing verifiable evidence of their academic, professional regulatory bodies.
- Verifiable evidence of registration as a Federal Government Licensed Auctioneer with relevant professional body.
- Verifiable evidence or participation in Auction exercise in Federal Government Establishments.
- Current Certificate of Compliance issued by the National Pension Commission as evidence of Compliance issued by the National Pension Commission as evidence of compliance with the Pension Reform Act 2004.
- Current Certificate of Compliance issued by Industrial Training Fund (ITF) in compliance with Section 6(2) of the ITF Amendment Act 2011.
- "Evidence of current registration on the national Database of Contractors, Consultants and Service Providers" by submission of Interim Registration Report issued by BPP (Bureau of Public Procurement).
