- (e) Evidence of current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate.
- (f) Evidence of registration on National Data-base of Federal Contractors, Consultants and services provider by submission of Interim Registration Report (IRR).
- (g) Sworn Affidavit disclosing whether or not any officer of the relevant Committees of the Federal Polytechnic Nasarawa or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- (h) Company Audited Accounts for the last three (3) years.

- (i) Evidence of Financial capability to execute the Projects by submission of Reference letter from a reputable Commercial Bank.
  - (j) Company profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/professional qualifications.
  - (k) Verifiable documentary evidence of at least three (3) SIMILAR Jobs successfully executed in the last five (5) years with names of clients, including Letter of Awards, Valuation Certificates, Job completion certificate and photographs of the projects. Document submitted shall be subject to due diligence without recourse to bidder.
