- (j) List of key personnel and evidence of proficiency and experience.
- (k) List of Equipment owned or on lease hold by the Company relevant for smooth execution of the project.
- (l) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Yusuf Maitama Sule University, Kano, Kano State or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- (m) A Sworn Affidavit that no of the Directors have been convicted in any country for any criminal offence including fraud or financial impropriety.
- (n) A Sworn Affidavit that none of the Directors have been convicted in any country for any criminal offence including fraud or financial impropriety.
