(i) List of plants/Equipment with proof of ownership/lease for lot 1 (zonal intervention)

(j) Verifiable documentary evidence of at least three (3) similar jobs in the last five (5) years including letters of Awards Valuation Certificates, Job Completion Certificates and Photograph of the projects:

(k) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Kenule Beeson Saro-Wiwa polytechnic or the Bureau of Public Procurement (BPP) is a former of present Director. Shareholder or has any pecuniary interest in the bidder and to confirm that all Information presented in its bid are true and correct in all particulars.

(I) Evidence of financial capability to execute the project including Reference Letter from a reputable Commercial Bank indicating willingness to provide credit facility.

(m) For joint Venture/Partnership, Memorandum of understanding (MoU) should be provided.

(n) Only companies included in the National Automotive Design and Development Council's approval list of local manufacturers of vehicles or their authorised representatives should bid for Lot 2 under year 2017 (Tetfund) Zonal Intervention.

(o) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's Letter Headed Paper bearing amongst others, the Registration number (RC) as issued by the Corporate Affairs Commission (CAC), Contact Address, Telephone Number (preferably GSM No,), and Email Address, the Letter headed
