#### **(1) INTRODUCTION:**

Management of Isa Kaita College of Education Dutsin-ma, Katsina State, hereby issues the general procurement notice to inform eligible Contractors, Suppliers, Vendors and the general public that the College is to undertake procurement of works and goods under Year 2015 and 2016 (merged) TETFund Normal Intervention in the following areas:

#### **(2) SCOPE OF PROJECTS:**

Projects to be executed and to which Technical/Financial bid documents of contractors are invited, includes:

#### **SCOPE OF WORKS**

Lot (1) Construction of one storey lecture hall complex

Lot (2) Construction of one storey Academic staff offices

Lot (3) Procurement and Installation of furniture and equipment for lecture hall complex and Academic Staff Offices

Lot (4) Construction of 2Nr. Block of Male and Female students' Lavatory.

Lot (5) Supply of 1Nr. 16-Seater Bus.

(3) Note that the bid documents would be evaluated on responsiveness to criteria including but not limited to:

(a) Certificate of Incorporation with Corporate Affairs Commission (CAC).

(b) Company's Tax Clearance Certificate for the last three (3) years (2015 – 2017).

(c) Evidence of Current Pension Compliance Certificate from PENCOM. (2018)

- (d) Evidence of current Industrial Training Fund (ITF) Act No. 19 of 2011. (2018)
  - (e) Evidence of current Nigerian Social Insurance Trust Fund (NSITF) compliance certificate (2018)
  - (f) Evidence of Registration on the National Data base of Federal Contractors, Consultants and service providers by submission of Interim Registration Report (IRR) expiring on 1/1/19 or valid certificate issued by BPP.
  - (g) Company audited account for the last three (3) years (2015, 2016 and 2017).
  - (h) Evidence of Financial Capability to execute the project. Bank reference and a letter of credit facility from a reputable Commercial Bank with a commitment to provide loan facility for the execution of the contract if eventually won.
  - (i) List of similar, verifiable and successfully executed projects or ongoing by the Company (at least three) with letters of award and Practical completion certificates, in the last five years. Letters of award and interim certificates of payment should be attached for projects that are ongoing.
  - (j) List of key personnel and evidence of proficiency and experience.
  - (k) List of Equipment owned or on lease hold by the Company relevant for smooth execution of the project.
  - (l) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Isa Kaita College of Education Dutsin-ma or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
  - (m) A sworn affidavit that none of the Directors have been convicted in any country for any criminal offence including fraud or financial impropriety
  - (n) Functional e-mail Address and GSM numbers.
  - (o) Detailed Company Profile including Curriculum Vitae CV of Key Personnel.
- (4) Interested and eligible Contractors, Suppliers and Vendors are advised to lookout for the Specific Procurement Notice (NPN) for the various projects and goods mentioned above in the National Dailies and the Notice Boards depending on the threshold of each project.
