(k) List of Equipment owned or on lease hold by the Company relevant for smooth execution of the project (where applicable).

(l) Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Umar Suleiman College of Education, Gashua or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
